## TEMPORARY CONSTRUCTION EASEMENT

Know all men by these presents:  ANTHONY K MIRZAIE and
That HERITAGE Fine Homes LLC, Homes LLC, Homes Loc , of Cleveland County, State of Oklahoma, for and in consideration of the sum of Ten Dollars (\$10.00) and other good and, valuable consideration, has/have this day sold to the City of Norman, a temporary easement over the following described land to wit:  A strip, piece, or parcel of land lying in the Northeast Quarter (NE 1/4) of Section 16, Township 8 North, Range 2 West of the Indian Meridian, Cleveland County, Oklahoma. Said parcel of land being more particularly described as follows:
COMMENCING at the Northeast corner of said NE I/4 of said Section 16, THENCE South 89°06'58" West along the North line of said NE I/4, a distance of 95.83 feet, THENCE South 00°53'02" East a distance of 50.00 feet to the POINT OF BEGINNING, THENCE South 45°37'50" East a distance of 14.08 feet, THENCE South 89°06'58" West parallel with the North line of said NE I/4, a distance of 100.00 feet, THENCE North 00°53'02" West a distance of 10.00 feet, THENCE North 89°06'58" East parallel with the North line of said NE I/4, a distance of 90.09 feet to the POINT OF BEGINNING. Containing 950.44 sq. ft. or 0.02 acres, more or less.
With the right of ingress and egress to and from the same, for the purpose of surveying, laying out, constructing, maintaining, and operating a public roadway, drainage structure or utility.
The sole purpose of this easement is to grant to the City of Norman the right to work on the above-described tract of land, and includes the right to use and remove any and all sand, rock, dirt, gravel, and other road building materials from the above-described tract of land.
It is a condition of this easement that it shall not be filed for record and that all rights conveyed to the City of Norman by this instrument shall terminate upon completion of construction of the project.
