Lindsey Street Resolution. Mr. Mike Rainer, 4705 Augusta Drive, commended Councilmember Karjala for bringing the resolution supporting Lindsey Street merchants forward.

Councilmember Allison also thanked Councilmember Karjala for working with the Lindsey Street merchants to coordinate this evening. He said he goes to Lindsey Street as much as he possibly can. He said these merchants have been having a hard time because of the construction and urged people to support them.

Councilmember Karjala asked everyone to visit Lindsey Street businesses.

Councilmember Chappel said he likes to see City Council united together supporting this issue.

## Miscellaneous Discussion, continued:

Oil Well Violations. Mr. Mike Rainer, 4705 Augusta Drive, said he had planned on speaking about this problem several weeks ago but instead agreed to allow the Oil and Gas Inspector to work with the company who was in violation. He presented several slides of alleged violations at the Madole #9 well site located north of Cedar Lane west of the railroad tracks. He said the inspection report for Madole #9 was done on April 5, 2016, which listed the required fencing was in place. He provided a slide showing there was not a gate provided by the oil well company, only a gate placed there by the owner of the property and there was no signage although signage is required. He said the only security feature was a chain placed there by the owner of the property and the only visible fencing was used to keep the cattle out. He saw the City of Norman Oil and Gas Inspector go into the site and the inspector was aware of what was going on. On Sunday, October 9th, he received permission from the property owner to go onto the property. He said the area was partially fenced but there is an area that is wide open which contains dangerous materials. He said the wellhead is exposed and the fence is upside down. He found an open gate to a tank battery and when he investigated he found a large oil spill and wanted Council to be aware of it. He said the operator spread wood shavings out on the oil literally adding fuel to the fire. He said the Corporation Commission shut down the lease prior to this because of various problems and the salt water disposal well on the other side of Highway 77 was shut down as well. He asked why the City of Norman has not looked into this and why they had not been shut down. He requested that the City shut this company down until they are compliant with all ordinances.

Councilmember Holman said the presentation was disturbing and he had no idea until this evening about this occurrence. He said this spill was only a few hundred feet from residences and it was very concerning that it was not being monitored properly. He thanked Mr. Rainer for providing the presentation. He said the amendments to the oil and gas regulations had taken a couple of years to complete and it is important that the ordinance be enforced.

Councilmember Castleberry said he has problems with people who intentionally break rules. He is very concerned about this but is confident that Staff will follow up on it.

Ms. Susan Connors, Director of Planning and Community Development, said the Oil and Gas Inspector went to the site on September 14th and at that time there was a "work-over" rig present. She said when a "work-over" rig is on a well, it is not required to be fenced. She said since that time, the "work-over" rig has been taken down, the posts have been put in but the fence is not completed. She said the operator was told today that the fence must be up by Friday, October 14th. She said the leaking tank battery occurred on September 13th and the operator immediately contacted the Oklahoma Corporation Commission and the City of Norman Oil and Gas Inspector. Both were on site that same day. She said the Oklahoma Corporation Commission has shut down all operations of Trinity Resources and the operator is not moving forward on any of their wells. The Oklahoma Corporation Commission is in control of the site now because of the size of the spill which contained both oil and salt water.

National Night Out. Councilmember Hickman said he appreciated the Norman Police Department for their hard work and efforts to make National Night Out a successful event. He was told that Norman Police Officers donate 16,000 hours of their time for community engagement and policing.

Councilmember Holman said he went to Cobblestone Creek for National Night Out and also got the opportunity to visit the Triangle Fraternity which is comprised of engineering students. He said he has always been interested in seeing the inside of this house and the fraternity president provided a tour. He really enjoyed his time there.

Councilmember Chappel said he appreciated the Police and Fire Departments coming to Ward 5 to visit the neighborhoods. He feels the City has a great public safety group working for the citizens.

Indigenous People's Day. Councilmember Clark said the University of Oklahoma has recently celebrated the second Indigenous People's Day. She said she played stickball during the event and really enjoyed it. She would like to see Norman get involved in this event as well.

Voices of Norman. Councilmember Clark congratulated the Xenia Institute for hosting the event "Voices of Norman", on Monday, October 10th. She is very excited to see the continuation of individual ward meetings to continue this important conversation.

Councilmember Holman said he attended the event which was done to build better relationships between the community and law enforcement. He said it was very well attended and there had been some great questions, although some of the topics were very difficult to talk about in public. He said these types of conversations need to happen in order to keep Norman from becoming one of the communities that is on the news.

League of Women Voters Candidate Forum. Councilmember Clark said the League of Women Voters would be hosting a candidate forum on Monday, October 17th at Norman High School at 7:00 p.m. She encouraged everyone to attend to learn about all of candidates and state questions to be voted on November 8th.

Read and Ride. Councilmember Clark said the CART "Read and Ride" event would be Saturday, October 22nd. She invited everyone to meet her and Doug Myers, Director of CART, at 10:10 a.m. at Bus Stop #49 which is just south of Homeland at 12th Avenue N.E. and Alameda to ride the bus with them. She said the full tour would take approximately one hour. She will be reading books to all the children and Mr. Myers will provide information about Norman and CART services.

Miscellaneous Discussion, continued:

Illegal Dumping. Councilmember Castleberry said he recently heard about illegal dumping in the Canadian River. He said if the construction company doing this is found to be illegally dumping without a permit, then they should pay the penalty. He said a strong message should be sent that the penalty will be greater than the benefit for those who pollute in Norman.

Councilmember Karjala said she has been attending Flood Plain meetings since May about this problem and it is looking like Sherwood Construction has violated the existing permit. She has made it very clear that the City should not condone businesses polluting and City Council needs to be united on this. She has heard from several of her constituents who are very unhappy and there has also been coverage on the news about this.

Mr. Shawn O'Leary, Director of Public Works, said the City has been working on this issue for the past five months. He said it has not been established that illegal dumping has taken place but there have been concerns about what was placed in the pit. He said for those who have not followed the case, the pit is located just southeast of Highway 9 and Interstate 35 where Sherwood Construction is working for the Oklahoma Department of Transportation (ODOT) on the Interstate 35 Project. He said Sherwood Construction acquired a floodplain permit from the City of Norman in October of 2013 for a barrow pit. He defined a barrow pit as removal of dirt and sand for use on a road project. He said no permit was acquired for filling the pit and when they applied for one, the Floodplain Committee rejected the permit application. Sherwood Construction appealed to the Board of Adjustment in August, 2016, and the Board of Adjustment sent the case back to the Floodplain Committee which met Monday, October 3rd, and postponed action, by a vote of 7-0, to dig a test hole in the fill area to determine if there was illegal material or pollution placed in the pit. He said staff has been working for the last week to establish a protocol and timeline. This item is scheduled to come back to the Floodplain Committee on November 7th.

Norman North Football Game. Councilmember Castleberry invited everyone to come to the football game Friday night between Norman North High School and Tulsa Union. He said the game would be at Norman High School Harve Collins Field.

Passing of Larry Walker. Councilmember Allison announced the loss of Larry Walker, a long-time Norman supporter and volunteer. Mr. Walker served as Chairman of the Public Arts Board since its inception. He asked everyone to keep Mr. Walker's family in their thoughts and prayers and thanked him posthumously for his service to the City.

Shop Norman. Councilmember Heiple urged everyone to "Shop Norman."

Environmental Concerns. Mayor Miller said City Council is in tune to environmental concerns and she appreciates members of the public who pay a lot of attention to these concerns and do a lot of study on their own. She says she also knows that City Staff is concerned about the environment and over the years there have been many rules put into place to add protection of the community's resources. Sometimes the bureaucratic processes do not work as quickly as we would like but when we stall out, it is important to ask what has been done and she appreciates Mr. Lewis calling staff members up to show that these issues are being worked on. She doesn't like it when these kinds of issues happen and she wasn't even aware there was a problem. She is usually relieved to find out staff did know about the problem and things are being done. She does not want to leave the impression with the public that the City is not concerned and it is important that they are getting regular reports about what steps are being taken.

**City Manager's Report**

**Sales Tax Update.** October sales tax revenue which represents sales during the month of August, 2016, was \$4,899,396, down \$130,252 or -2.59% from October 2015 levels. Sales tax receipts are now 3.86% below last year's level.

**NORMAN FORWARD UPDATE**

**Westwood Family Aquatic Center.** Phase 2 of the demolition and construction began this week. The Oklahoma State Department of Health has given final approval to move forward with the project and a notice to proceed was issued to W. L. McNatt and Company to begin work on Friday, October 14th. The project should be substantially complete and pool is set to open in the summer of 2017.

**Comprehensive Plan Meetings.** Moore, Iacofano, Goltsman, Inc., (MIG), has been updating the Comprehensive Plan. To follow the process, go to PlanNorman.com which has a lot of information about the process going forward. The Steering Committee which was appointed by the City Council will have their third meeting on Wednesday, October 12th, in the Lowry Room at the Norman Public Library from 6:00 p.m. to 8:30 p.m. Another public meeting will be held in the early spring to gather additional public feedback. There will be a Community Event booth set up at the Second Friday Artwalk on Friday, October 14th in front of the MainSite Art Gallery. The second opportunity for people to provide feedback will be at Campus Corner on Saturday, October 15th from 8:00 a.m. to 11:00 a.m. Norman.

**Comprehensive Plan.** The First Community Workshop was September 15th which identified Norman's assets in the community, such as park and trail systems, and also key challenges in the community such as the cost of living, stormwater management, pedestrian and bicycle connectivity. These issues compact the livability and our quality of life in the community.

#

**Animal Welfare News.** With the assistance of a very kind donation, the City was able to purchase an adoption and rescue trailer which was approved by City Council in February, 2016. The trailer has been outfitted and is available for use at off-site adoption events, community events, disaster response, and reinforcement investigation when there are a large number of animals that have been confiscated or transported to the Animal Welfare Center. The trailer's first event was October 2nd.

A new part-time veterinarian, Ms. Amy Tyler, D.V.M., has been hired at the Animal Welfare Center. Dr. Tyler graduated from Oklahoma State University in 1994 and has 22 years in general and emergency veterinary medicine. She has also worked with wildlife at Wild Care Oklahoma Foundation. This will be a great benefit to the animals at the shelter and will improve efficiency at the center because animals will be spayed and neutered at the shelter instead of being transported off-site. Rabies vaccinations will be provided and the general condition of the animals will be monitored on site as well.
