ORDER AWARDING THE NATURE AND EXTENT OF PERMANENT PARTIAL DISABILITY BENEFITS

Now on this 14th day of SEPTEMBER, 2015, this cause came on for consideration pursuant to regular assignment and hearing on SEPTEMBER 9, 2015, before JUDGE CARLA SNIPES, at Oklahoma City, Oklahoma, at which time claimant appeared in person and by counsel, DAVID B CUSTAR appearing for RICHARD A BELL and respondent and insurance carrier appeared by counsel, JEANNE SNIDER appearing for R BLAINE NICE.

The Court having considered the evidence and records on file, and being well and fully advised in the premises FINDS AND ORDERS AS FOLLOWS:

-1-

THAT on MARCH 22, 2007, claimant was employed by the above named respondent and such employment was subject to and covered by the provisions of the Workers' Compensation Code of the State of Oklahoma; and on said date claimant sustained accidental personal injury to the RIGHT KNEE (aggravation of pre-existing condition), and consquential LEFT HIP, RIGHT HIP, LOW BACK, and LEFT KNEE arising out of and in the course of claimant's employment.

- 2 -

THAT at time of injury, claimant's wages were sufficient to establish the rates of compensation at \$577.00 per week for temporary total disability and \$289.00 per week for permanent partial disability.

THAT as a result of said injury, claimant sustained 0 percent permanent partial disability to the LEFT HIP and 12 percent permanent partial disability to the RIGHT HIP over and above 10 percent pre-existing permanent partial disability and 5 percent permanent partial disability to the LOW BACK over and above 9 percent pre-existing permanent partial disability to the RIGHT KNEE over and above 50 percent pre-existing permanent partial disability and 5 percent permanent partial disability to the LEFT KNEE over and above 10 percent pre-existing permanent partial disability, for which claimant is entitled to compensation for 153.75 weeks at \$289.00 per week, or the total amount of \$44,433.75 of which 35 weeks have accrued and shall be paid in a lump sum of \$10,115.00.

- 4 -

THAT respondent or insurance carrier shall furnish claimant with continuing medical maintenance of said condition as a result of claimant's injury with RIGHT KNEE for maintenance of prosthetic until further order of this Court pursuant to the Physicians Advisory Committee Guidelines.

- 5 -

THAT respondent and/or insurance carrier shall pay all reasonable and necessary medical expenses incurred by claimant as a result of said injury.

- 6 -

THAT respondent or insurance carrier shall pay claimant the accrued portion of the award herein in lump sum of \$10,115.00 and pay the balance of said award at the rate of \$289.00 per week until the total award of \$44,433.75 (less attorney fee) has been paid to claimant.

- 7 -

THAT Respondent shall pay court costs; Special Occupational Health and Safety Fund Tax of three-fourths of one percent (0.75%) of the amounts paid in lump sum of \$333.25 is levied against the Respondent; three-fourths of one percent of the continuing benefits awarded in this case shall be computed and paid as the same comes due. Pursuant to 85 O.S., Section 407, as amended by Laws 2013, HB 2201, c. 254, Section 49, eff. January 1, 2015, Respondent, if Own Risk, shall pay \$888.68 to the Workers' Compensation Administration Fund created by 85 O.S. Section 407, to be used for the costs of administering the Workers' Compensation Code as applicable to the Oklahoma Workers' Compensation Court of Existing Claims, representing two percent (2%) of the permanent disability award herein.

THAT pursuant to Title 85 O.S. Section 368, a final award fee of one hundred forty dollars (\$140.00) is taxed as a cost in this matter, and shall be paid by respondent.

THAT the sum of \$8,886.75 shall be deducted from the award herein and paid in lump sum to claimant's attorney as a fair and reasonable attorney fee; within twenty (20) days from the date of filing of this order, respondent or insurance carrier shall comply herewith.
