MISCELLANEOUS DISCUSSION

<u>Water Issues and Upcoming Water Meetings</u>. Mr. Bobby Stevens, Post Office Box 6226, said Council needs to consider the water shortage before approving plats in the future. He said <u>The Norman Transcript</u> had published an article suggesting citizens with water wells should be monitored to show water usage because City wells and private wells were also affected by the low water table. He suggested photographs showing how much the water table had dropped at Lake Thunderbird be displayed at each City Council meeting. He felt citizens were unaware of the water problems Norman has and it is important for everyone to understand that this is a serious crisis.

Councilmember Castleberry announced the Strategic Water Supply Plan Public Meeting would be held Wednesday, March 13, 2013, at City Hall. He said these meetings are designed to provide information to the public about what the consultants are doing and to allow citizen input.

Mayor Rosenthal said the meeting will be held from 6:30 p.m. to 8:30 p.m. and is the long-term piece of water planning extending to 2060. She said it is extremely important for citizens to be engaged in this forum. She said Monday, April 1st is another Public Forum presented by Utilities Staff and members of the Environmental Control Advisory Board to provide short term solutions during the drought period ranging from ways to save water when taking care of the lawn, in the home, and during planting and replanting. She agreed with Mr. Stevens that a visual picture of the lake should be provided to the citizens. She said those who are not following mandatory water rationing procedures should be reminded to look at Lake Thunderbird.

CITY MANAGER'S REPORT

Comprehensive Transportation Plan Upate. The Comprehensive Transportation Plan Update was postponed which was originally scheduled during the Study Session on March 5th because the presenter had been unable to attend. It has been rescheduled for Tuesday, April 2, 2013.

Library Lighting Project. The Norman Public Library was constructed in 1965 and the lighting in the library has never been replaced or updated. He said \$325,000 had been set aside over the last few years for these needed improvements. He said the Library Lighting Replacement Project is in the process and at this time the Lowry Room and meeting rooms are complete and the Children's area is underway. Mr. Lewis said citizens' patience is appreciated during this project.

Traffic Signal Projects. Three new traffic signal projects have recently been approved by City Council which are being funded 100% by Federal monies. These projects are located at the intersections of Jenkins Avenue and Brooks Street and Jenkins Avenue and Stinson Street and at 24th Avenue S.E. and Reagan Elementary School. He said the projects should be completed in the next few months.

Repairs to Bridges on I-35. Emergency repairs to the Lindsey Street overpass at I-35 began March 9th and should be completed tonight. Similar problems could evolve on the Indian Hills Road Bridge over I-35. City Staff is working to partner with the Oklahoma Department of Transportation (ODOT) for the funding for the Indian Hills Road Bridge Project. He said ODOT awarded the contract for repairs to the deck on March 4th and the City's share is \$250,000 which is more than anticipated. He said this construction should begin this Spring.
