Circumstances of Claim: Claimant was driving her vehicle northbound on Berry Road, approaching Nebraska Street. City Vehicle driven by Jonathan Robert Dora was southbound on Berry Road, approaching Nebraska Street. City Vehicle crossed center line and into the northbound lane of Berry Road. City Vehicle struck Claimant's vehicle and continued off of the road. A witness claims the City Vehicle's driver was slumped over the wheel at the time of the collision. As a result of the incident, Claimant suffered injuries to her person and her vehicle was damaged. (Supporting documents attached).

Nature of Injury: The Claimant's suffered injury to her neck and shoulder as a result of the accident. The injury required her to undergo arthroscopic surgery on her shoulder, followed by physical therapy to return her arm to its full function. Claimant incurred expenses for pre- and post-operative medication. Claimant was forced to use all her accumulated paid leave time and additional unpaid leave available through her employer. Claimant's vehicle was damaged as a result of the injury and was deemed a total loss by Claimant's insurer.

Compensation Demanded: Compensation for costs of property damage, medical care, lost wages and pain and suffering associated with Claimant's injuries in the total amount of \$224,523.00.
