MISCELLANEOUS DISCUSSION

<u>Legacy Park</u>. Ms. Melissa Scaramucci, 4401 Cannon Drive, thanked City Council and Mr. Jud Foster, Director of Parks and Recreation, for approving the resolution to allow alcohol in Legacy Park for special events.

<u>Veteran's Day Parade</u>. Mr. Roger Gallagher, 2513 Woodsong, said the Veteran's Day Parade is held on a Saturday to allow school kids to get as much exposure to the parade as possible. He said each year the Veteran's Day Committee tries to organize donations and military units and much of the detail work is done by City Staff. He said two Staff members that do not get any acclamation are Jud Foster and Sheryl Sheriff, Parks and Recreation Department. He thanked them for their hard work in helping to organize the event.

Ms. Ann Gallagher, 2513 Woodsong, said she was in charge of the volunteers for the Veteran's Day Parade. She said there were a lot of volunteers from University of Oklahoma (OU) students who worked two hour shifts and she never had less than ten people helping. She said the Assisteens volunteered to help as well and there has never been a more energetic set of kids wanting to help with anything that needed to be done. She thanked both of those groups for volunteering and for their hard work. She said many members of community also stepped up to make donations and help.

Councilmember Heiple thanked the veterans for their service and said he and his wife, April, got to ride in the parade, which was quite a treat. He said the Veteran's Day Parade is quite an event and he is thankful for the opportunity to be a part of that. He encouraged everyone to attend next year is they have not had that experience. Shop Norman!

Councilmember Castleberry thanked the veterans for their service.

Councilmember Holman said his grandfather served in Korea and his only uncle is the Adjunct General of Oklahoma, which is the highest ranking military official in the State. He appreciates the service of those in the military as wells as veterans and reminded everyone that it is our duty as citizens to do everything possible to make sure we never send our service members into harm's way if at all possible.

Councilmember Lang extended his heartfelt thanks to the veteran's.

<u>Public Safety Sales Tax and Norman Forward Sales Tax</u>. Mr. Steve Ellis, 633 Reed Avenue, said Mr. Anthony Francisco, Finance Director, provided information on the discrepancy between the Public Safety Sales Tax (PSST) and the Norman Forward Sales Tax (NFST); however, he feels there is still a discrepancy in FYE 2016 versus FYE 2017.

<u>Economic Development Advisory Board</u>. Ms. Cindy Rogers, 633 Reed Avenue, attended the Economic Development Advisory Board (EDAB) meeting and was very impressed with the care the Board took in looking into the items they were tasked with. She is still pushing for a Fiscal Impact Analysis and hopes that will be on their agenda soon.

<u>Elections</u>. Councilmember Williams said in two weeks the Council will decide when the even numbered Council Wards and Mayoral election will be held. He said anytime a candidate runs for office, it takes an immense amount of discernment and a lot of time to plan a campaign. He feels it appropriate at this time to publicly announce he will be not seeking a second term on Council. It has been a great privilege and a moment of pride in his life to serve and to continue to serve until the end of this term, but the work at Mary Abbot Children's House has continued to expand and grow and he feels he needs to focus his efforts on that work.

Councilmember Allison said he is sad to hear Councilmember Williams will not run for a second term.

Councilmember Castleberry said he is sorry to hear that as well.

Miscellaneous discussion, continued:

Zero Based Budgeting. Councilmember Castleberry said the Finance Committee will be discussing zero based budgeting on Thursday, November 12th and thanked the Mayor for placing that on the agenda. He said for those who do not know what zero based budgeting is, it is basically justifying all expenses. He said this is the public's money and the City needs to justify how they spend that money.

Mayor Rosenthal thanked Councilmember Castleberry for his acknowledgement and would note this is a very important policy decision. It was Councilmember Castleberry's intent to have that item on tonight's agenda as a Rule of Three, but missed that deadline by 24 hours. She said discussing zero based budgeting in the Finance Committee will allow Council to spend thought, consideration, and study on the item and encouraged all Councilmembers to participate in that discussion.

<u>City Council Meeting Attendance</u>. Councilmember Holman thanked everyone for attending the meeting tonight. He has always been an advocate of getting citizens to attend the Council meetings especially meetings that are non-controversial because, usually, meetings with controversial items are well attended. He said citizens can learn how the Council meeting process works and meet their Mayor and Councilmembers as well as City Staff that work behind the scenes. He said most of the student housing is in his ward and students can contact him anytime with questions, comments, or complaints.

<u>Speeding</u>. Councilmember Lang said he has continually complained about speeding on Tecumseh Road and recently received a speeding ticket on that road and absolutely deserved it. He has been traveling the speed limit for the last two weeks and is amazed how many people speed. He said there are a lot of streets in Norman that look like a raceway, and asked everyone to please slow down.

CITY MANAGER'S REPORT

*

<u>State Highway 9 East</u>. Mr. Steve Lewis, City Manager, said the Oklahoma Department of Transportation's (ODOT) State Highway 9 East Widening Project between 36th Avenue and 72nd Avenue has begun. This is a \$22 million project being done by Silver Star Construction under the direction of ODOT. He said demolition is occurring at the Dave Blue Creek Bridge on the south side of Highway 9 and a temporary road is being constructed on the north side of Highway 9 to allow for construction of new southbound lanes.

<u>Federal Emergency Management Agency</u>. Mr. Lewis said the Federal Emergency Management Agency (FEMA) Community Rating System audit is underway. Those residents in Norman that purchased flood insurance through the National Flood Protection Program currently receive a 25% discount on the flood insurance because of the many activities the City is involved with in terms of its Floodplain Management Program. Recently a team from FEMA reviewed how the City administers the Floodplain Ordinances in the community as well as reviewing the Floodplain Ordinance, stormwater detention requirements, Stormwater Master Plan, and how the City handles the Emergency Action Plans for high hazard events in Norman. This audit takes place every five years and it is important for the City to do well during the audit to continue to receive the 25% discount on flood insurance for our residents.

<u>Fall Cleanup</u>. Mr. Lewis said the City recently completed the fall cleanup program, which is one of the most popular services offered by the City. He said over 858 tons of materials were collected for a total cost of \$93,000. He thanked all the departments that helped with that cleanup program. He said this program is really about keeping Norman beautiful and the most common items collected are couches, fence panels, grills, lawn furniture, swing sets, trampolines, etc. These are items that tend to clutter up backyards and side yards in the community.

Mayor Rosenthal said Norman is going to be recognized by Keep Oklahoma Beautiful later this month for all the various activities in the City of Norman that show good stewardship for the environment and resources. She said it is a special honor of distinction and Norman was chosen for leadership shown in the different areas including fall cleanup.

<u>Norman Forward Program</u>. Mr. Lewis said the City needed to retain consulting help to manage the Norman Forward program. The City released a Request for Proposals (RFP's) and received four proposals from really qualified firms. The fundamental goal is to be able to establish very aggressive, yet achievable schedules within Norman Forward and the City obviously wants to meet or beat all the budgets set for the projects. A recommendation to Council will hopefully occur soon and give the City a smooth start on construction of the new facilities within the community.
