MISCELLANEOUS DISCUSSION

Congratulations to New Councilmembers. Mr. Bobby Stevens, Post Office 6556, congratulated the new Councilmembers.

Disaster Relief Projects. Mr. Bobby Stevens, Post Office Box 6556, said it has been said that the federal funds received for the Community Development Block Grant Disaster Relief (CDBG-DR) Projects is free money and he responded that this money came with a very high price, because people in Ward Five were hit by tornadoes and burned out by wild fires with lots of loss of life and property and many were not able to rebuild. He said he is very pleased that the City worked on getting this money to rebuild the roads. He said these roads are dangerous and should be striped. He asked when the road construction would begin.

Ms. Joy Hampton, The Norman Transcript, 215 East Comanche Street, said she was working on a story for The Norman Transcript about these incredible grants received by the City of Norman and Cleveland County to repair and upgrade the roads damaged during the tornadoes and wild fires. She asked everyone to look for the article.

Mayor Miller said there will be an information update regarding the progress of the projects.

Storm Water Election. Mr. Bobby Stevens, Post Office Box 6556, said he was very pleased to see such a good turnout for the Storm Water Election.

Councilmember Holman expressed his appreciation to everyone who has gotten involved in the Storm Water Utility discussions. He said the issue has been discussed for many years but many people were not interested until something had been placed on the ballot. He said now people are bringing up questions that did not come up before and whether it passes or not, a good plan will come forward.

Councilmember Clark thanked everyone who voted in the election. She said this should be a great turnout. She also urged everyone to be nicer to each other during this process.

Mayor Miller said when she voted today at 2:30 p.m. there had already been 300 voters, and she understands that was happening all over town. She said one way to get everyone's attention is to take something to the citizens for a vote. She said Norman is unique where there must be a vote of the people before the utility rates can be increased. She said whether it passes or fails, Council and staff have a huge job to do. If the proposal passes, credits and an appeal process will have to be determined and if it fails, Council and Staff will have to go back to the drawing board because this funding source is desperately needed. She said in all the meetings, Council and Staff had been listening to the citizens and taking notes and this information will be used in the planning process. She thanked Mr. Shawn O'Leary, Director of Public Works and Scott Sturtz, City Engineer, who presented information at all of the meetings and Ms. Claudia Deakins, the Communications Officer, who has worked at computer non-stop for 8 weeks to provide good public information. She said this is one of the reasons the citizens have understood the process and how complex it is.

Ward Five Facebook Page. Mr. Bobby Stevens, Post Office Box 6556, said a few years ago a Ward Five Facebook Page had been created and now there were 440 people in the group.

<u>Blue Cards</u>. Mr. Bobby Stevens, Post Office Box 6556, hoped that the new Council will stop using the blue cards giving notice that someone has questions about the Consent Docket. He said citizens should get to ask about items without writing it down and the questions should be answered publicly.

<u>Senior Center</u>. Councilmember Heiple said State Representative Emily Virgin had sent a letter to the Attorney General requesting a determination about whether or not the City could use the 2008 General Obligation Bond proceeds for a stand-alone Senior Center and he is excited about that.

Shop on Lindsey Street. Councilmember Karjala said people need to shop at businesses on West Lindsey Street. She said when people shop locally it affects sales tax which funds municipal government. She met today with Lindsey Street Merchants Association, the Chamber of Commerce, and City representatives to find ways to help these merchants during the construction project. She said businesses are closing at a rapid rate and by the time the construction is finished, many businesses will be gone. These business people are very concerned about their livelihood because they are making half as much as they were last year. She said Councilmembers Clark and Hickman recently met with her for lunch at Legends and they all invited some friends. She said they are planning on doing these luncheons up and down Lindsey Street and she will be posting invitations on Facebook.

Councilmember Allison said "Shop Norman" and please continue going to those Lindsey Street businesses.

Councilmember Holman agreed and encouraged Ward 7 residents to frequent the West Lindsey Street businesses.

<u>Bicycle Friendly Community</u>. The City of Norman is currently "Bronze" level and there have been several bicycle-related transportation, parking, and signage projects that will hopefully raise the City's status. Results are expected this fall.

City Manager's Report, continued:

<u>Police Body Cameras</u>. This is the final week of field testing for 12 body cameras from three different vendors. The Police Department is planning a presentation to City Council in an upcoming study session to provide field test results and to review the policy that will govern how the body cameras will be implemented and answer issues that come up relative to data storage.

<u>Construction Update</u>. City staff has received many questions in terms of the progress of the Main Street construction. City departments are closely coordinating projects with each other and with Norman Public Schools to sequence construction to balance the impact on school food service operations, students, parents, and motorists. To improve the situation, the contractor is doubling their onsite workforce this week and on weekends. Other city crews are facilitating some of the work and will be working overtime as well. The City has been using quick drying concrete which allows the concrete to cure in one to three days where regular concrete takes seven to ten days to cure. The roadway adjacent to Norman High School is scheduled to reopen before Labor Day (September 5th). Concurrent with this, the Police Department and Traffic Division have been working with the University of Oklahoma (OU) to prepare all roadways for the first Football Game day.
