THENCE South 89°45'02" West a distance of 88.04 feet to the POINT OF BEGINNING;

THENCE continuing South 89°45'02" West a distance of 11.96 feet;

THENCE North 45°15'18" West a distance of 56.63 feet;

THENCE North 00°20'58" West a distance of 14.95 feet;

THENCE South 45°13'18" East a distance of 44.16 feet;

THENCE North 89°45'02" East a distance of 20.82 feet;

THENCE South 00°14'58" East a distance of 23.76 feet to the POINT OF BEGINNING.
