MISCELLANEOUS DISCUSSION

City Council. Councilmember Kovach thanked Councilmembers Dillingham and Quinn and their families for the time they put into serving the citizens of Norman. He said it takes a lot of effort and support to serve on City Council. He said Councilmember Dillingham spent a great deal of time on many issues and went the extra mile and he will miss her. He said Councilmember Quinn has always been an honorable member of the Council and kept Councilmembers on task and wished him great success. He said elected officials are a like a team for Norman and although they may not always agree, they respect each others opinions and come together for the good of the community. He said Norman's motto is "An Inclusive Community" and inclusive does not mean only getting along with people you agree with. It means everyone in the community has a place in the community and he feels strongly that people need to look beyond labels to see people with ideas, hopes, and dreams. He said Norman needs to come together as a community on issues that challenge the community and do what is right for the future by respecting one another.

Miscellaneous Discussion, continued:

Councilmember Ezzell welcomed Councilmembers Jungman and Williams to the Council. He said it has been a privilege to know and serve with Councilmember Dillingham. He said he would miss serving with Councilmember Quinn as he was an inspiration when it came to chairing committee meetings. He wished both Councilmembers the best.

Councilmember Jungman congratulated and thanked Councilmember Dillingham for her service on Council. He thanked his family for their support during his campaign as well as his supporters and said he is looking forward to serving Norman.

Councilmember Spaulding welcomed the new Councilmembers. He said the last year serving on Council has been the most fulfilling year of his life and felt serving on Council would be fulfilling for them as well. He said he did not go to Norman Public Schools so he did not know Councilmember Quinn as well as other Norman citizens, but, not long ago, as he was going through some trying times on Council, Councilmember Quinn told him not to take citizens remarks personally. He said one of his regrets in life was not having gone to law school and he has enjoyed Councilmember Dillingham's legal perspectives during Council meeting debates and he would miss her.

Councilmember Griffith welcomed the new Councilmembers and said although the learning will be intense, it will also be a very exciting time. He thanked those who helped and supported him during his re-election bid. He said when he decided to run for office, Councilmember Quinn was the first person he called for advice and was told serving on Council would be time consuming, but rewarding and he should run. He said he admires Councilmember Quinn's leadership abilities as well as his integrity and wisdom. He said he has truly enjoyed getting to know Councilmember Dillingham and her dialogue on the dais is inspiring. He said she brings the more subtle issues to life and has caused him to rethink his position on issues many times. He said it has been a privilege to serve with both of them and he will miss them.

Councilmember Lockett congratulated the new Councilmembers. She said there is much to learn, but it is an exciting time and she wishes them well.
