Water Reclamation Facility. Councilmember Holman said the Water Reclamation Facility is located in Ward 7 and this is where all of the sewer systems go to. He said this facility generates an odor, but finally thanks to Norman voters and City staff, the City is investing about \$63,000,000 to improve the facility and included in the equipment is for odor control. He said although the odors cannot be eliminated, new equipment has been installed and must go through rigorous testing to ensure it is operating properly. He said the performance tests show the equipment has made a significant improvement from removing 99% of the hydrogen sulfide odor at each location and the final pieces of equipment will be installed this fall for more improvements to this area.

CITY MANAGER'S REPORT

<u>Sales Tax</u>. July sales tax revenue was \$4,619,039 which reflects sales tax receipts during the month of May. This is an increase of \$70,124 or +1.54% from July 2016.

<u>Griffin Park Sports Complex</u>. Final Master Plan presentation will be the subject of the City Council Conference on August 1st. The plan includes an expansion of the outdoor soccer facility, new lighting, irrigation systems, and much needed transportation improvements adjacent to the park.

<u>Reaves Park Sports Complex.</u> Revised Master Plan is to be presented to Reaves Park Citizen Ad Hoc Group on Wednesday, July 21st.

<u>Westwood Tennis Center</u>. City staff is beginning work on the plans and specifications for the new two-court indoor tennis facility beginning with the site survey and soil testing and completed construction drawings.

<u>Westwood Aquatic Center</u>. Progress continues with many of the water features at Westwood Aquatic center including the lazy river and water slide features and the new bathhouse and concession stand.

<u>Lake Thunderbird</u>. June, 2017, has been reported to be the second driest June recorded in Oklahoma history. The City of Norman is currently in Stage One of the Conservation Plan which is the odd/even water rotation system based on street address. This is a year-round water rotation program and sometimes people forget that this program does allow people to use soaker hoses any time they want to or use a hand held hose that has a positive shutoff nozzle. People are encouraged to be watering on the odd/even water rotation system. Private owners of water wells used for irrigation purposes are exempt. A few years ago, summer conservation rates were adopted that adds an additional 35 cents per 1,000 gallons for each 1,000 gallons that are above 20,000 gallons for each month in July and August. This conservation charge is presently in effect.
