MISCELLANEOUS DISCUSSION

New Fire Station. Ms. Jacy Crosbie, 204 Mountain Oaks Drive, said the residents of Royal Oaks Addition were very excited about the opening of Fire Station No. Nine located nearby because it was hoped that homeowners' insurance would go down when it was operational. She said she called her insurance company to inform them and request for a reduction in rates and the insurance company said they had no record of the fire station and it was up to the City to notify them. She requested that someone from the City call them.

Mr. Steve Lewis, City Manager, said one of the things that will improve is the International Organization of Standardization (ISO) rating but that might not happen for quite a while. He said part of the function of Fire Station No. Nine is to act both as an urban fire station and a rural fire station. He said first tanker truck that is received in the spring might increase the rural component of the ISO rating.

<u>Thanks to Permit Division</u>. Mr. Harold Haralson, 516 Avon Drive, said he recently had the opportunity to obtain a permit for the storm shelter and said the process was handled efficiently and he commended Staff for this.

*

<u>Citizens Solutions</u>. Mr. Evan Dunn, 621 Cruce Street, Apt. 4, said he hosts gatherings at public parks from time to time and invited everyone to join him on Sundays with Citizens Solutions where he provides a community event that welcomes all venues, such as music, discussion, poetry readings, art, and even manual labor. He said he had recently trimmed some shrubs at the Amphitheatre at Andrews Park during one of the events.

Councilmember Miller told Mr. Dunn his presentation reminded her of something she recently read, "That which unites us is of God and that which does not unite us is not of God" She said this is a community and Mr. Dunn is speaking to all of us.

.

Temperature in Council Chambers. Ms. Ann Gallagher, 1522 East Boyd Street, said although it had been warmer in Council Chambers last week, it was back down to 69 degrees and that is too cold. She said this is not energy efficient and asked that someone do something about this.

*

Conflict of Interest. Mr. Harold Heiple, 2011 Morgan Drive, said he knows the language of the Ethics Policy and what "the appearance of" means. He said appearance just like beauty is in the eye of the beholder and more than 40 years ago when he was a Councilmember there were two very fine University of Oklahoma faculty members who served on Council with him. He said there have been many people who have served on Council since that time that were connected to the University of Oklahoma, both faculty members and administration. He said if you went on "appearance of" conflict of interest, there probably would not be anybody from the University of Oklahoma serving on Council because there are so many things that are done on every agenda that in some way relate to the University. He said the conflict would have to be connected to a financial interest, so Councilmember Castleberry had a financial interest in the widening of Lindsey Street and he properly recused. He said Mayor Rosenthal is exactly right in her analysis that her situation as a tenured faculty member does not require her to recuse herself. He said with respect to people who feel otherwise, it is appropriate that everyone to realize that without the University or without people connected to any other large employer of the community, membership on Council would be confined to a very small group of people. He said the beauty of Norman is the diversity of our population and the diversity of the membership of Council. He feels that the Ethics Policy has been correctly followed.

*

Recycling in Highland Hills Addition. Councilmember Heiple thanked Ken Komiske, Director of Utilities, and Steve Lewis, City Manager, for helping Highland Hills Addition get recycling in their neighborhood.

Miscellaneous Discussion, continued:

Lindsey Street. Councilmember Heiple said he is pleased with the Lindsey Street plan because the City is getting 100% of what was approved by voters with a better plan. He believes the discussion about roundabouts will be fun; however, whether there are roundabouts or stoplights, there will be a bottleneck when it goes from four lanes to two lanes. He said the question is what tool is appropriate to make it better. He said Council is listening to the engineers in order to make the best decision. He said the bottleneck might not go away but this is an opportunity to make history and create a great street leading into Norman and the University of Oklahoma and he thanked the Institute for a Quality Community (IQC), the Boren Group, and the Burden Group.

Councilmember Kovach said the public should also be thanked and they had also spoken pretty loudly about what their expectations were when they approved the bond election.

Councilmember Miller said she was so appreciative at how many people attended the public meeting on September 3rd. The entire room was full with so many different constituencies, the bike riders, the residents who live on either side of Lindsey, the business owners, and the disabilities community. This type of participation will help Council make good decisions. She said she has been skeptical and asked many questions but she really appreciates that the University has pushed Council and she feels because of this, Council and Staff have come up with a better project. She said she appreciated the City Engineers who had to redo several things in order to come up with a better plan.

Councilmember Williams said when he asked for more public comment of the Lindsey Street Project in Study Session, he never expected a roomful of people and it was very gratifying to see residents from Ward 8, who live nowhere close to Lindsey Street, come and give their opinions. He said it was very helpful and asked for the public to keep providing input, no matter which side of the issue they support.

*

Contract Oversight. Councilmember Kovach said fiscal responsibility had been discussed this evening and although there had been nothing wrong with what Staff had done, he still questioned the amount of the Amendment. He said it is time there is a policy about how much money can be expended in a construction contract without some kind of oversight by Council. He said there are certain segments that can be increased with no limit without any kind of Council review, in this case it had been over \$100,000. He said it is a good accounting practice to have oversight. He asked that this policy be looked at by Council.

Councilmember Williams said he would like to see discussion come through a Council Committee. He said it is very difficult to sit on Council and vote on something when you have to. He said he was approving something that had already been spent and if they are not paid, the City would have a problem. He said it is difficult to do so on such a controversial item.

Councilmember Castleberry said he would like the Finance Committee to look at the policy on contracts for professional services. He said he is very concerned that money was spent that was not in the budget or preapproved. He said if this item had not been approved by Council, it could have possibly hurt the City's chances to work with anyone wanting to do business with the City. He said approving something that has not been previously discussed is not a prudent fiscal responsibility. He said the same limitations should be applied to this contract as construction contracts.

.

National Night Out. Councilmember Holman reminded everyone that Tuesday, October 1st was National Night Out. He encouraged neighborhoods that wanted to participate to contact Sergeant Jennifer Newell, Norman Police Department. He said he looked forward to attending the events in Ward Seven.

*

Good Budget Numbers. Councilmember Castleberry said the City is \$1.8 million under the budgeted amount. He reiterated that when Council cut the budget in June, it was with the understanding that if the budget came back in a positive light, Council would reinstate some of the items cut from the budget, such as park programs, street sweeping, etc. He said he hoped when final numbers are received, some of these things would be put back into the budget as promised.

*

<u>Traffic Analysis Study</u>. Councilmember Castleberry said in the past whenever there was any kind of project being planned, a traffic analysis study would be done. He said if the level of service or traffic goes down, Council does not approve the project. He said he hopes that Council stays with this policy going forward, regardless of the project. He said if the level of service goes down, we are not improving traffic.

Miscellaneous Discussion, continued:

Sales Tax. Mr. Steve Lewis, City Manager, said September sales tax figures had been received and there was a 4.5% increase over last year which makes the cumulative increase for FYE 2014 5.5% over last year.

Citywide Fall Cleanup. Mr. Steve Lewis, City Manager, announced that utility customers would be seeing the Citywide Fall Cleanup schedule in the bills. He said Citywide Fall Cleanup begins on Saturday, September 28th for those who have Monday trash pickup; Saturday, October 5th for Tuesday pickup; Saturday, October 12th for Wednesday pickup; Saturday, October 19th for Thursday pickup; and Saturday, October 26th, for Friday pickup.

November 12th Election. Mayor Rosenthal said one of the most important things accomplished this evening was approval of the November 12th Special Election for a Wastewater Utility. She encouraged civic groups to contact the City if they are interested in receiving presentations on the rate increase. She said this is a very needed and very important critical increase for the community in terms of infrastructure. She said the City looks forward to taking the message to the community and speaking to anyone who is interested.
