MISCELLANEOUS DISCUSSION

Zero-Base Budgeting. Councilmember Castleberry thanked Council for adopting the Resolution acknowledging Zero-Base Budgeting Principles. He said he is the Certified Public Accountant on Council and he would be more than willing to talk cost accounting with anyone on Council. He said the fact that this item was placed on the agenda by a "Rule of Three" should not matter. He said these items should be judged on their merits, not necessarily the process. He said Council could have spent a year discussing this, but it instead it was accomplished this evening. He said the "Rule of Three" is in place to allow minorities to get issues on the agenda.

<u>Appreciation to Audience</u>. Councilmember Holman appreciated all who had attended tonight's meeting.

<u>City Council</u>. Councilmember Holman said although Council does not always agree on all issues, they get along pretty well. He said all nine Councilmembers live in the city limits and care about what happens in Norman. He said they might sometimes disagree about the way to get there but will continue to work together to continue addressing issues in the City of Norman.

<u>Happy Thanksgiving</u>. Councilmember Lang wished everyone a Happy Thanksgiving and urged everyone to be careful if they are traveling.

<u>Shop Norman</u>. Councilmember Lang said after everyone was through with celebrating Thanksgiving to please "Shop Norman" on Friday.

Mayor Rosenthal asked everyone to shop and support local businesses this weekend.

<u>Completion of Audit</u>. Mr. Steve Lewis, City Manager, said the City's auditing consultant, BKD, L.L.C., has completed their audit of the City's financial statements and presented it to staff on November 12th at the City Council Finance Committee. He said the auditors will be issuing an unqualified opinion of the City books which is a fair and accurate picture of the City's finances. The auditors submitted an opinion that there were no significant weaknesses in the City's systems of internal control. He said he appreciated the fine work of the auditors and Finance Department staff.

<u>Financing for the Norman Forward Projects</u>. Mr. Steve Lewis, City Manager, said the Finance Department staff, in consultation with the City's financial advisor, is soliciting bid proposals for the financing of \$43,160,000 in tax-exempt revenue notes to pay for the preliminary costs of the Norman Forward Sales Tax packages. He said two to three financial packages to pay for the debt-financed portions of the Norman Forward Sales Tax Program are estimated to be sold over the life of these projects. He said bids from qualified financial firms are due on December 8th.

<u>LEED Certification</u>. Mr. Steve Lewis, City Manager, said the Norman Fire Department has received notification that Fire Station No. 9 located at 3001 Alameda Street achieved Leadership in Energy and Environmental Design (LEED) Silver certification. He said some of the key features are the use of 30% less energy of similar buildings in size; reduction of domestic water use by 50%; drought resistant landscaping; and many other features that are included in building a sustainable structure. He said Fire Station No. 8 had received Gold Certification. He said he is very pleased with the work of the Fire Department and the architects that designed both buildings.
