Item 1, being:

CART RIDERSHIP REPORT INCLUDING SAFERIDE AND EXTENDED SERVICE.

Mr. Doug Myers, OU Parking and Transportation Administrator, distributed the May 2013 Cleveland Area Rapid Transit (CART) Ridership report. Chairman Griffith asked if anyone had any comments and/or questions regarding the CART May, 2013 CART Ridership report and no comments and/or questions were received.

Item 2, being:

CONTINUED DISCUSSION REGARDING A DRAFT ORDINANCE ESTABLISHING HIGH-DENSITY RESIDENTIAL ZONING DISTRICTS.

Mayor Rosenthal said this afternoon the Norman Economic Development Coalition (NEDC) voted not to sell the NEDC property located at 710 Asp Avenue and has issued a position statement which was distributed to the Community Planning and Transportation Committee (CPTC). The position statement indicated after careful thought and deliberation, NEDC decided a well-defined vision and comprehensive plan needs to be developed for the Campus Corner and downtown areas. The statement also indicates NEDC believes a true vision for the overall development of Norman's core areas of Campus Corner, downtown Norman, and the connecting corridor is necessary before proceeding further.

In the position statement, it also noted that President Boren has pledged the University's resources and support to develop this vision through the Institute for Quality Communities. Accordingly, President Boren respectfully supports a process led by the Institute for Quality Communities, to include community leaders and interested parties to examine, deliberate, and establish a clear vision and comprehensive development plan for the Campus Corner and downtown Norman corridors.

Item 2, continued:

NEDC and President Boren support a collaborative and inclusive approach and respectfully request that the City of Norman and other involved parties withhold any action on new ordinances that would limit the scope of this plan until the completion of a visioning process and development plan for the Campus Corner to Main Street Corridor.

Mayor Rosenthal felt the community needed to “step back and take a deep breathe” and accept NEDC and University’s request to forego any action regarding high density ordinances until a positive vision has been created for the Campus Corner and downtown Norman corridors. She said there are concerns regarding the high density ordinance coming forward at this time and the ordinance may perhaps create negative conditions rather than positive. Mayor Rosenthal said she has spoken to Mr. George Wilson, Chair NEDC Board, and he indicated there are very constructive ways to look at the corridor and create a well-defined vision that will benefit the entire community.

Mayor Rosenthal said she appreciates and thanks NEDC for a very thoughtful debate and their decision. She felt that NEDC wishes only the best for the community and wants to be a part of this visioning process.

Chairman Griffith said sending a high density ordinance forward to Planning Commission may be premature in light of the fact there is not a clear vision for Campus Corner and downtown Norman and the Committee agreed.

Councilmember Gallagher said the Committee needed to keep in mind that the thrust of the entire project will affect all of Norman, not just the University. He said he understands the University will be a very important part of the equation, but felt the reasoning, rationale, and control regarding high density needed to stay with the City and Council.

Chairman Griffith asked if NEDC had given any kind of a timeline for the visioning process and Mr. Steve Lewis, City Manager, said a scope of work will need to be developed; therefore, there currently is not a timeline for the visioning process. Chairman Griffith asked whether the CPTC will be involved in discussions during the visioning process and Mayor Rosenthal said absolutely, the process will involve community leaders, Council, etc. She said not only the zoning piece, but the issues regarding the parking, traffic, financial, etc., will be worked through during the visioning process. She said the visioning process and unified plan can holistically create an area that works for walkability, transit, and traffic.
