Budget Narrative – Consultants and Contracts

The consultant and contract costs listed above are directly associated with the department's attempt to address at-risk missing persons, on-going traffic enforcement complaints and furthering our forensic services through training. The Care Trak on-site training allows us to maximize the number of personnel capable of using the system to locate at-risk missing persons. The eCitation warranty is required since this device will be shared among multiple users and subject to field conditions thereby reducing the risk of non-use due to a failed tool or more expensive repair/replacement. The eCitation licensing is required for each tool that uses the proprietary software. The Crime Scene Certification and forensic course tuition is the minimum tuition for these courses (or their equivalent) that we could find in combination with travel costs.
