### MISCELLANEOUS DISCUSSION

<u>Citywide Striping</u>. Mr. Bobby Stevens, Post Office Box 6226, said he wanted striping on Post Oak Road because it is dangerous and when traffic is redirected from Highway 9, the traffic becomes really heavy.

Ambulance Service vs. Wrecker Services. Mr. Bobby Stevens, Post Office Box 6226, said there are only five ambulances to take care of the people in Norman 24 hours a day, seven days a week. He said there are only 6 wrecker services in rotation to handle all of the wrecker calls for the City but only five ambulances. He said he also had a problem with Public Safety Sales Tax being used to support EMSTAT because EMSTAT had nothing to do with Public Safety.

Help for the Silk Stocking Neighborhood. Ms. Ellen Frank, 211 East Daws Street, said she lived in the Silk Stocking neighborhood and expressed concerns about her neighborhood because it had become a hodgepodge of multiple zoning districts. She requested help from the City to develop the best plan to make this a more vibrant neighborhood for Core Norman. She asked what steps should be taken to start this process.

The Mayor said the neighborhood plan for Silk Stocking Neighborhood should be revisited. She asked Ms. Susan Connors, Director of Planning and Community Development to meet with Ms. Frank.

Councilmember Jungman said he would like to look at the neighborhood plans for neighborhoods in the vicinity of the campus because there are many different types of zoning that look like R-1 but really are quite different.

Miscellaneous Discussion, continued:

Resolution Supporting Sooner Rail. Ms. Mary Francis, 850 C Cardinal Creek Condos, thanked Council for adopting Resolution No. R-1314-108 urging the Oklahoma Department of Transportation and the State of Oklahoma to retain ownership of the Sooner Passenger Rail Line. She said Norman has joined Oklahoma City, Tulsa, and Stillwater in supporting this issue and that she had attended the City of Oklahoma City Council meeting this morning where the resolution had been adopted unanimously. She explained that the state owned rail system from Oklahoma City to Sapulpa is 97 miles and the Oklahoma Department of Transportation wants to sell it. She said if they sell it, the state owned railroad would lose the right-of-way, property, and the 99 year lease allowing four round trip passenger service trains per day for the last 18 miles into downtown Tulsa at \$9 per rail mile, which is incredibly cheap. She said it was important to maintain ownership and control of future rail initiatives.

New Audio/Visual System at City Hall. Mr. Roger Gallagher, 1522 East Boyd Street, said the old audio/visual system did not allow people in the back of the room to see the PowerPoint presentations or hear speakers and asked if the new ones would. Ms. Brenda Hall, City Clerk, said the cameras would be new and the look will be crisper and brighter.

Handouts to the Public. Mr. Roger Gallagher, 1522 East Boyd Street, said some presenters at Committee meetings were considerate of the public and provided handouts while some only had enough for the Committee Members. He asked if additional handouts could be provided to the public at future meetings.

Street Sweeping Program. Mr. Roger Gallagher, 1522 East Boyd Street, said there was a street sweeper on 36th Avenue West where the street already looked clean and wondered if Public Works was still keeping a log showing which streets were cleaned and when. Mr. Shawn O'Leary, Director of Public Works, said yes a log was still kept and today special cleanup was being performed to pick up the sand utilized in the recent snow and ice removal.

Councilmember Castleberry said he knew the streetsweepers were cleaning Lindsey Street because he saw two of them at 4:00 a.m. one morning. He said he appreciated it.

<u>Three Unrelated Persons Living in One House Ordinance</u>. Mr. Roger Gallagher, 1522 East Boyd Street, said he supports no change to the ordinance regarding three unrelated persons residing in one residence.

Approval of Ordinance No. O-1314-28. Mr. Roger Gallagher, 1522 East Boyd Street, said he was glad Council had approved the ordinance allowing a Bed and Breakfast at 1405 McKinley. He said a Bed and Breakfast is not negative in any community.

<u>Safety Problems in Schools</u>. Mr. Roger Gallagher, 1522 East Boyd Street, said the recent report about the safety report for Moore Schools raised concerns and asked if Norman Schools could be checked for the same kind of safety violations.

Ms. Joy Hampton, The Norman Transcript, 215 East Comanche, asked Chief Fullingim if these inspections showed the structural integrity of the buildings.

Mr. James Fullingim, Fire Chief, said the purpose of the inspections was to check how the intended structure would hold up during a severe storm. He said the structural integrity of a building would be hard to determine unless a building was completely dismantled.

Miscellaneous Discussion, continued:

Ordinance No. O-1314-29. Mr. Jay Cervi, 2614 Lauriston Drive, said he had come this evening to discuss the Ordinance granting Special Use for a Private School/Early Education Center for 2795 Broce Drive. He said it appears there had been a change to the original request because an additional lot had been added for a playground and asked if the applicants would be required to start over because the configuration had changed Mr. Jeff Bryant, City Attorney, said during the short recess, there had been discussion with the attorney for the applicant about this change and the attorney would be meeting with his clients to see if they should stay with the original plan or make changes. Mr. Cervi said he had protested this zoning change because a traffic problem exists at the intersection of Broce Drive and 36th Avenue West. He said there are several businesses that require semi-trucks and trucks hauling trailers making deliveries, etc. He requested Staff look into this.

He said the even/odd water rationing program will be taking effect in a few days and citizens will be reminded of this in the next utility bill. He said area irrigation contractors have been reminded that systems should be upgraded with rain sensors.

<u>Bulk Water Dispenser.</u> Mr. Steve Lewis, City Manager, said a bulk water dispenser was being installed across the street from the Water Treatment Plant to allow rural customers to purchase water during the summer months for livestock and for home use when they might experience issues with their water wells.
