INFORMATION: Pursuant to 25 O.S., Section 307(B)(4) a public body is permitted to conduct an executive session to discuss confidential communications between the city and its city attorney regarding pending litigation upon advice of the city attorney that the disclosure of such communication will seriously impair the ability of the public body to proceed in the litigation and under Section 307(B)(1), a public body is permitted to conduct an executive session to discuss the employment, hiring, appointment, promotion, demotion, disciplining or resignation of any individual salaried public officer or employee. Thereupon, this item is submitted for City Council's consideration.
