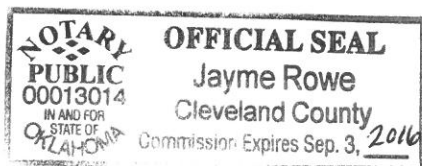

Thence North 88°50'09" East a distance of 30.00 feet;

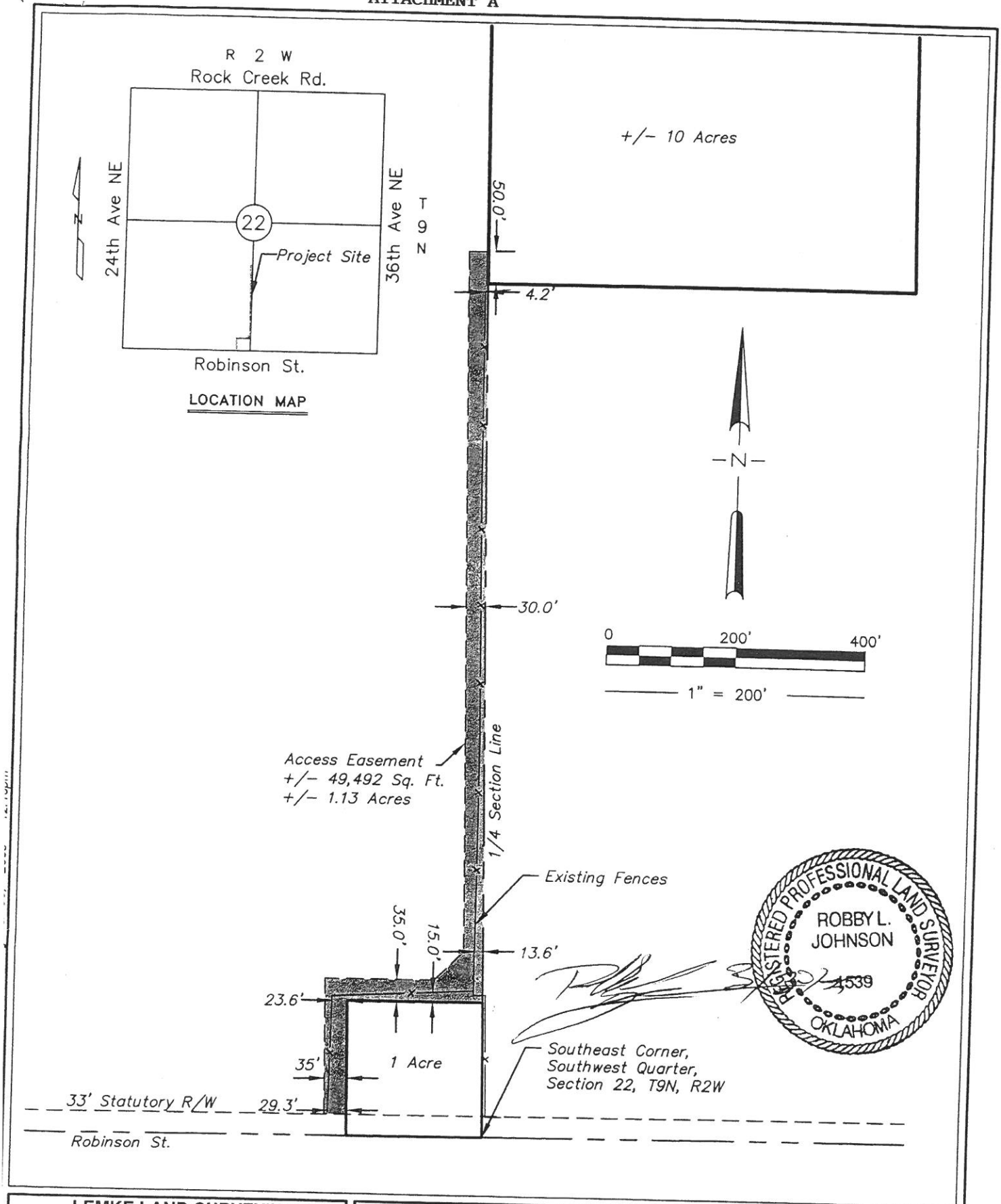
Thence South 01°09'39" East a distance of 1159.64 feet;
