RE: **Protest and Objection** to Application for Rezoning - 801 36<sup>th</sup> Avenue N.W. - Wally Kerr Scheduled for Public Hearing and Consideration on April 10, 2018

We, the undersigned neighbors in the vicinity of and affected by the subject property, do hereby petition and request that the City Council vote **AGAINST** any rezoning of the subject property ( a **NO** vote ).

Following more than a year of neighborhood discussions, many meetings, including some with City Staff, our Councilperson, and most recently with the Applicant's attorney, we continue to believe that maintaining the current zoning is in the best interest of the neighborhood and the Norman community as a whole.

There is **NO** compelling interest to change the zoning.

Over ninety percent (90 %) of the owners of homes within the 350 foot Notice Radius filed Protest Letters with the City. When excluding City owned property, the owners of over sixty-three percent (63 %) of the land area within the 350 foot Notice Radius filed Protest Letters. Additionally, at least 27 other nearby concerned residents filed Protest Letters.

The City Council meeting on April 10th, will be the fifth City public hearing / meeting that neighbors have attended to discuss and protest rezoning of the subject property.

We do not want another postponement !

Please vote **NO** to reject the rezoning request.
