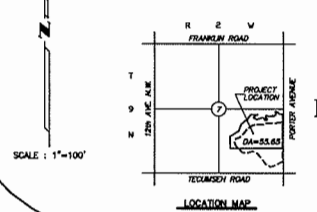

GRANTEE DETENTION FACILITY EXISTENCE AND NEEDED EXPANSION AS SHOWN TO PROVE FOR DETENTION OF STORM SURGE WATER AND CONSTRUCTED AS APPROVED BY THE CITY ENGINEER. ALL WORK DONE WITHIN THE DRAINAGE DETENTION FACILITY EXISTENCE SHALL BE THE RIGHT, DUTY AND RESPONSIBILITY OF THE PROPERTY OWNERS IN THE PLAT OF THE DRAINAGE DETENTION FACILITY. THE CITY ENGINEER, IN RESPECT TO THE CITY ENGINEER'S DUTY AND RESPONSIBILITY, IS DETERMINED TO BE A HAZARD OR THREAT TO PUBLIC SAFETY BY THE CITY ENGINEER. CONSTRUCTION SHALL BE FINISHED BY THE CONTRACTOR, MANAGEMENT WITH COOPERATION AND SOUND JUDGMENT. THE PROPERTY OWNERS, OFFICIALS REPRESENTING THE ENGINEERING DIVISION, PUBLIC WORKS DEPARTMENT, AND THE CITY ENGINEER, SHALL BE RESPONSIBLE FOR THE PROTECTION OF PERIODIC INSPECTION AND/OR CORRECTIVE MAINTENANCE OF THE FACILITY. UPON RECEIVING WRITTEN APPROVAL FROM THE ENGINEERING DIVISION, PUBLIC WORKS DEPARTMENT, AND THE CITY ENGINEER, THE PROPERTY OWNERS SHALL BE RESPONSIBLE FOR THE MAINTENANCE OF THE FACILITY. THE FACILITY SHALL BE USED FOR THE PURPOSES AND NOT INTERFERE WITH THE FUNCTION OF THE DETENTION FACILITY.
