MISCELLANEOUS DISCUSSION

Protesters at Norman Schools. Ms. Valerie Lambert, Ward 1, said on Friday, February 21st. members of Abolish Human Abortion (AHA) protested and held up very graphic signs for six days at Norman High School. She said she and several parents asked the protesters to please move across the street and instead they moved very close to her, got in her face, and were threatening to her as well as all the students going in and out of Norman High School. She values First Amendment rights; however, she requested a buffer zone be created outside of schools. She said a school is not the place to push this type of agenda and it is not a safe environment for young people. She said her daughter did not want to go to school while the protesters were there. This group is very intimidating and many students were crying. She said they asked probing questions and the images on the signs are not appropriate for children. She said because the group is located in Norman, all of the students of Norman will be relentlessly targeted by them. She said presently the group is protesting at Norman North. The group is standing 5 to 6 people deep at the end of the crosswalk with large signs and the students have to walk through them. She said although a buffer zone would not stop the propaganda, it would move them far enough away to allow the students the choice to walk through them or not. She said there are many upset parents who do not understand why something cannot be done. She asked for help from City Council.

Ms. Miranda Steffen, Ward 3, said her son goes to Norman North and the protesters came to his school Monday, March 24th. On the first day, she said she respected the fact that the protesters only held up their signs with a picture of the website. She said she was not present when her son got on the bus to go home but found out they were more aggressive. She said she has been watching the school and the protesters only come up a few minutes before lunch starts or schools lets out and then they follow the children and harass them. She said they are not doing this on school property but are targeting the back of Norman North. She said she has younger children and they are seeing this. She requested Council approve a buffer zone.

Miscellaneous Discussion, continued:

<u>Protesters at Norman Schools</u>. Ms. Brooklyn Jackson, Ward 2, said she has no children in high school but has one in middle school and one in grade school. She said she supports a good protest and does not mind signs with words. She said she opposes the large graphic pictures that can be seen from the road and everyone, including very young children, sees it.

Councilmember Castleberry said he is very troubled by what is happening and had the opportunity to meet Ms. Lambert when this first happened. He said his son is on the Cross Country Team at Whittier Middle School and practices at Norman North so he was confronted by the protesters. He said the images are not suitable for this age group and supports creating buffer zones. He said he would like the Oversight Committee to look at this. He said schools are places of learning and the environment needs to be safe for young people. He said the buffer zone allows freedom of speech while providing a conducive, learning environment. He felt the City should provide public safety.

Mayor Rosenthal said the City Attorney's Office has done some research about buffer zones. She expressed concerns about the disruption to the learning environment and the aggressive nature of certain types of protests, irrespective of their topic. She said this research will be presented by the City Attorney at the soonest possible opportunity in a Study Session. She said Staff will make those attending tonight's meeting aware of the date of the meeting.

Cleanup at House. Mr. Bobby Stevens, Post Office Box 6226, said he would like to have the hole in front of his house filled in and the pile of trash cleaned up.

Striping on East Side. Mr. Bobby Stevens, Post Office Box 6226, requested striping on Post Oak Road between 84th Avenue S.E. and 156th Avenue S.E. and received a reply that it could not be done because 1,000 cars do not travel down that road on a daily basis. He argued that when Highway 9 is shut down and traffic is rerouted, there were 1,000 cars on that road a day.

Election for Public Safety Sales Tax (PSST) and City Council. Mr. Bobby Stevens, Post Office Box 6226, said he supported public safety and believed the PSST Election would be successful. He said he received a brochure and had attended the Ward 5 meeting. He wanted more Code Enforcement and Animal Control on the east side of Norman. He said he felt the sales tax should be a temporary sales tax and there should be more ambulances and would like an ambulance on the east side.

Mr. Roger Gallagher, 1522 East Boyd Street, said the brochure was very well done and well explained but looked expensive. He asked whether it was prepared by an outside company or City Staff and wanted to know the total cost of the brochure including postage.

Councilmember Kovach said he did not know what the cost of the brochure was but citizens had reminded Council that some of the meetings had not been televised or could not be viewed for some citizens of East Norman; therefore, Council had been asked to provide different ways to get the information out to the whole community. He said when there is a vote of the people involved, it is important to send complete information out to the entire community.

Councilmember Kovach reminded citizens that early voting for the April 1st Election starts on Friday, March 28th. He said besides PSST, Wards 2, 4, and 6 were up for consideration by the public. He encouraged citizens to spend a little time to get to know the candidates and choose the one they think will do the best job.

He said the forum would concentrate on the responsibilities of City Council making fiduciary decisions. He welcomed attendance.

Street Sweeping. Mr. Roger Gallagher, 1522 East Boyd Street, said he asked for information about the schedule for street sweeping and had not received a response. He asked the City Manager if he had information.

Mr. Steve Lewis, City Manager, said he thought Mr. Gallagher had been contacted by Staff and would be contacted by Mr. Shawn O'Leary, Director of Public Works, to answer questions.

Audio Visual Project Update. Ms. Brenda Hall, City Clerk, thanked everyone for being patient while the bugs are being worked out of the new Audio Visual System. She said the project will not be completed until the end of April; however, within the next few weeks all of the programming issues should be worked out. She said the contractor is here this evening and will be at the next meeting to work through the issues as they happen. She said the electronic voting piece is not complete but when it is, Council will vote at their chairs and the vote will be displayed on the screen to the public as she restates audibly what the vote is.

Resurfacing on Main Street. Councilmember Castleberry thanked Staff for including several resurfacing projects in Ward 8 in the 2014 Urban Concrete Rehabilitation Bond Project approved by Council this evening.

<u>Lindsey Street Public Meeting</u>. Councilmember Kovach announced the Lindsey Street Public Meeting has been rescheduled for Thursday, April 3, 2014, at Sooner Legends at 6:00 p.m.

<u>Community Oriented Policing</u>. Councilmember Heiple said Community Oriented Policing is working and commended Chief Humphrey because the Oxford House issues have been reduced substantially.

Recycling for Highland Hills. Councilmember Heiple announced recycling for Highland Hills Addition is very successful and thanked staff for allowing this to happen.

Water Pressure at Summit Lakes Addition. Councilmember Heiple said water pressure in Summit Lakes Addition will improve after the distribution lines and water tower are completed.

<u>Deer Crossing Signs on East Lindsey Street</u>. Councilmember Heiple said he would be working with City staff to install deer crossing signs on East Lindsey Street.

Center City Visioning Committee Meeting. Mr. Steve Lewis, City Manager, said the Center City Visioning Committee will be meeting Wednesday, March 26th, at 6:30 p.m. at the fellowship hall at St. John's Episcopal Church located at 235 West Duffy. He said the meeting is open to the public with the purpose of giving the public an understanding of the vision of this project and to hear from citizens about their aspirations. He said the study area includes the East and West Main Street area, the Campus Corner area, and the residential area in between these areas with Gray Street on the north, Boyd Street on the south, the railroad tracks on the east, and Flood Street on the west.

Mayor Rosenthal encouraged those interested to come to the meeting.

Retail Market Analysis. Mr. Steve Lewis, City Manager, said City Council recently approved a retail market analysis and the importance of this has been discussed many times. He said 58% of the General Fund is sourced by sales tax and this fund is used along with the Public Safety Sales Tax Fund to assist and deliver our important services, such as Police, Fire, Code Enforcement, Parks and Recreation, etc. He said part of this study being will address gaps in our retail establishments in the community. He said part of that survey will be distributed online through the City's website and through social media. He said the survey will work hand in hand with the market analysis and it is hoped it will come together with good feedback from citizens in terms of additional retail businesses and restaurants that they would like to see in the community. He said Staff looks forward to the citizens' participation.

*

Spring Cleanup. Mr. Steve Lewis, City Manager, said Spring Cleanup will begin April 5th for those with Monday trash pickup, April 12th for Tuesday pickup; April 19th for Wednesday pickup; April 26th for Thursday pickup; and will conclude on May 3rd for those with Friday pickup. He said rural customers have Spring Cleanup services available, but will need to call ahead to allow Staff to coordinate pickup at the appropriate time. He said Spring Cleanup does not include yard waste; remodeling and/or demolition debris; broken concrete; bricks and lumber; construction debris; junk cars; sheetrock and shingles; and hazardous waste. He said if there are questions about when and what can be picked up, call Sanitation at (405) 329-1023.
