**DISCUSSION BY THE COMMISSION**

Mr. Morgan noted there is a 10.55% deviation between wards, which is considerably higher than last year. He asked how the numbers would compare to past years when a change was recommended. Ms. Clayton commented that in the past the deviation has been as high as 23%. Ten percent is kind of a rule of thumb. The City Council does not like to make changes in the wards, so in the past the Commission has waited until a change really needs to be made. There were no changes made from 2005 to 2011. During that time, the Commission made recommendations for changes but the Council did not adopt them. Ms. Schmitz noted that in 2010 the deviation was over 27%. Ms. Connors added that the City Council knows they have to look at this differently at the time of the census than during the intervening years.

Ms. Connors asked what happened in 2005 that a change was made. Ms. Clayton responded that the change was made in 2004. In 2003, Hall Parks was annexed. In 2004, the deviation was 15.98%, so it was adjusted and went down to 10.87% in 2005. In 2006, it was 16.96%; 2007 – 19.1%; 2008 – 19.9%, and it went up higher from there. In 2010 the Council elected not to adopt the Commission's recommendation for ward adjustments because the census was coming up.

Mr. Greenleaf commented that at the time of the census the Cleveland County Election Board was also doing new precinct assignments, so it fell into line to make a change in 2011 because the precinct lines were going to change whether the ward boundaries changed or not. He does not think we will be able to go as long without a change as the period from 2005 to 2011.

*David Morgan moved that the Reapportionment Commission recommend to the City Council that no changes be made to the Ward boundaries. Karl Jahnke seconded the motion.* There being no further discussion, the motion was adopted by a unanimous vote.

Ms. Connors noted that there is potential for development to happen along Indian Hills Road in Ward 8. Ms. Clayton commented that growth in any of the wards, other than Ward 5 and Ward 6, would help the deviation. Ms. Connors added that housing on OU property is not counted.
