MISCELLANEOUS DISCUSSION

Safety Issues and Code Violations. Mr. Bobby Stevens, Post Office Box 6226, provided a photograph of a hole in the road in front of his house. He said he informed City employees and scheduled a meeting with City staff to take care of the problem. He said he had also talked to the Code Enforcement Department about Code problems. He said it was important for everyone to know that because of budget cuts there are not enough employees to work all of the issues which has created public safety issues.

Thanks to Animal Welfare Staff. Mr. Bobby Stevens, Post Office Box 6226, thanked Animal Welfare staff for helping his mother get her dog back.

Temperature. Ms. Ann Gallagher, 1522 East Boyd Street, expressed concern with the temperature in the Council Chambers and felt the City is not being energy efficient.

*

Miscellaneous Discussion, continued:

Volunteer at the Police Department. Ms. Ann Gallagher, 1522 East Boyd Street, thanked the Police Department for allowing her to volunteer last weekend by putting out door hangers about safety and awareness in neighborhoods in Core Norman. She said it was a great experience and a great service to the neighborhood. She said she received many thank-yous from residents in the neighborhood.

Mayor Rosenthal thanked officers for putting out the door hangers in her neighborhood.

*

Issues in Core Norman and Landlord Registration. Ms. Ann Gallagher, 1522 East Boyd Street, said landlord registration had been discussed in the past and felt the idea should be revisited because although there are many homes in Core Norman that are very well taken care of, there are many that are not. She said there is a lack of sidewalks or damaged sidewalks in some areas and multiple cars are parked at houses indicating there are more people living in the houses than what is legally allowed. She said many of these homes have concreted over the backyard to allow for more parking.

Councilmember Holman said he did not know if landlord registration is the best way to address these issues but there is a definite problem. He said he lives next to an apartment complex where only four units out of 28 are occupied. He used to live in these apartments and they were so terrible, he moved to the house next door. He said the owner does not repair problems and would remove tenants who complained. He said his block does not have street lights or sidewalks and there are many young ladies who walk in the street at night time which is not safe. He said he lived in an apartment in the past that had so many code violations, he and all the other tenants were asked to vacate the premises within two hours by the Fire Marshall. He said this apartment house is still empty and has never been improved or maintained at all.

*

New Recycling Contractor. Ms. Ann Gallagher, 1522 East Boyd Street, commended the new recycling contractor for helping her move a heavy polycart.

Councilmember Griffith said he had only received one complaint and that was about the color of the containers. He said his container is full and he is anxious for it to be picked up.

*

Adopt Pets from the Animal Welfare Center. Ms. Ann Gallagher, 1522 East Boyd Street, encouraged citizens to adopt a pet from the Animal Welfare Center. She said her experience and the adopted pets have changed her life.

*

PISCES Water Festival. Mr. Roger Gallagher, 1522 East Boyd Street, said the PISCES group is have a water festival to celebrate 50 years of organized competitive swimming in Norman on Saturday, August 17, 2013, from 6:00 to 8:00 p.m. at Westwood Swim Complex. He said there are various forms of entertainment and PISCES is encouraging people to put together relay teams for a 100-yard freestyle event.

*

Grass Problems. Mr. Roger Gallagher, 1522 East Boyd Street, said after the recent rains, high grass at the roadsides is a problem and should be addressed.

Councilmember Griffith said many commercial lawn contractors are blowing their grass clippings into the street which goes into the storm drains. He said he plans to stop and remind people this is a violation of City Code. He said it was also a safety issue because the grass makes the roads hazardous for bicyclists and motorcyclists.

Wastewater Rate Public Meeting. Mr. Roger Gallagher, 1522 East Boyd Street, said he attended the Public Meeting about the Wastewater Rate Increase on Monday, August 12th and approximately 15 people were in attendance which is not good when it involves such an important issue. He said the meeting had not been televised and he had been disappointed about this. He hoped next time the meeting would be televised.

Miscellaneous Discussion, continued:

Restaurant Waste. Mr. Evan Dunn, 621 Cruce Street, said he had recently been working in the food industry and encountered a great deal of waste on the part of management. He said the lack of awareness is disappointing and when he suggested ideas about recycling or composting, he was told it would slow things down too much. He said food service workers are put under a lot of pressure to get the product out in a timely manner. He commended businesses in Norman who do take the time, such as the Earth, Trey's Cantina, the Grey Owl Coffee shop, and Scratch.

Absentee Shawnee Clinic. Councilmember Miller said she visited the Absentee Shawnee Clinic recently and it is a beautiful facility and a Leadership in Energy and Environmental Design (LEED) certified building, which offers all services including optometry, psychiatry, and dental. She said these services are available to non-natives as well.

*

Ride-Along with the Police Department. Councilmember Miller said she did a "ride-along" recently and thanked Officer Wiles, Lieutenant Barbour, and Lieutenant Callaghan for allowing her to ride with them. She said it was a great experience riding around in East Norman.

Councilmember Holman said he will be going on a "ride-along" this coming Friday in Ward 7.

School Starts Soon. Councilmember Holman urged citizens to proceed with caution because school will be starting soon. In the University of Oklahoma area there are many people walking in the streets.

Thanks for Watching the Meeting. Councilmember Holman thanked everyone for their attendance at the meeting tonight and to those who watched at home.

Glad To Be Home. Mayor Rosenthal said it was good to be back and wanted to dispel the rumor that she sprained her ankle kicking her dog or Councilmember Castleberry because it was not true.

City Manager's Report

Sales Tax Report. August Sales Tax remittance was received for the period ending in June. He said amounts have increased by 8.8% over last years' totals.

Citywide School Zone Flasher Project. School starts on August 21st and the Traffic Control Division is in the process of completing the Citywide School Zone Flasher Project which includes 28 locations. This project will give Staff the ability to operate the flashers remotely and the flexibility to adjust the flashers during times school is not in session or when there are early dismissal times.

Legacy Park Project. There have been setbacks in the Legacy Park Project but Staff is hoping that the park will open by April, 2014. The contractor recently completed the installation of the concrete piers that support the west arbor of the band shell in the entry portal structure.

Crime-Free Multi-Housing. The Police Department will soon be announcing that the first apartment complex has completed training and implementation of the Crime Free Multi-Housing Program. This is a voluntary program and there are three to four apartment complexes participating at this time.

New Recycling Contractor. This is the second week of services with the new contractor for curbside recycling program. Republic Services invested approximately \$1 million in equipment to implement this new service in Norman. Republic worked last Saturday and plans to work this Saturday in order to overcome obstacles related to the transition. Two new maps are on the City website to help citizens determine which group they are in, Group A or Group B, and then there is an interactive map where a person can type in their address to give the information.
