THENCE South 89°45'02" West a distance of 90.00 feet to the Point of Beginning;

THENCE South 89°45'02" West a distance of 24.99 feet;

THENCE North 45°16'38" West a distance of 35.35 feet;

THENCE North 00°20'57" West a distance of 25.05 feet;

THENCE South 45°15'18" East a distance of 70.77 feet to the POINT OF BEGINNING.
