

GRANT OF RIGHT-OF-WAY  
City of Norman

Know all men by these presents:

That University Town Center, LLC, for and in consideration of the sum of One Dollar (\$1.00), receipt of which is hereby acknowledged, and for and upon other good and valuable considerations, do hereby grant, bargain, sell and convey unto the City of Norman, a municipal corporation, a public utility easement and right-of-way over, across, and under the following described real estate and premises situated in the City of Norman, Cleveland County, Oklahoma, the following described land to wit:

A strip, piece or parcel of land lying in the Eastern Half (E1/2) of Section Twenty-Three (23), Township Nine (9) North, Range Three (3) West in Cleveland County, Oklahoma. Said parcel of land being described by metes and bounds as follows:

Commencing at the Southeast Corner of the Southeast Quarter (SE1/4) of Section 23; Thence S 89°25'31.09" W along the South Section Line of said Section, a distance of 1,582.36 feet; Thence N 00°34'29.70" W a distance of 2,422.73 feet, to a point on the Existing Easement, the same point being the Point of Beginning.  
 Thence N 88°55'14.34" W a distance of 25.00 feet to a point on the Existing Right-of-Way;  
 Thence Northerly along a curve to the right having a radius of 1,942.19 feet, a chord bearing and distance of N 08°33'19.91" E, 378.78 feet, for an arc distance of 379.38 feet;  
 Thence N 60°47'47.92" E a distance of 27.96 feet;  
 Thence Northerly along a curve to the right having a radius of 1,922.19 feet, a chord bearing and distance of N 15°00'34.06" E, 1921 feet, for an arc distance of 1921 feet;  
 Thence N 30°26'13.91" W a distance of 27.79 feet;  
 Thence Northerly along a curve to the right having a radius of 1,942.19 feet, a chord bearing and distance of N 21°35'28.62" E, 387.36 feet, for an arc distance of 388.00 feet;  
 Thence North N 40°27'06.09" E a distance of 98.55 feet;  
 Thence Northerly along a curve to the right having a radius of 1,922.19 feet, a chord bearing and distance of N 33°19'48.46" E, 211.50 feet, for an arc distance of 211.61 feet;  
 Thence N 36°29'02.09" E a distance of 235.62 feet;  
 Thence N 76°15'47.09" E a distance of 7.16 feet;  
 Thence S 64°06'45.49" E a distance of 0.42 feet;  
 Thence S 36°29'02.09" W a distance of 241.20 feet;  
 Thence Southerly along a curve to the left having a radius of 1,897.19 feet, a chord bearing and distance of S 19°44'04.17" W, 1,105.02 feet, for an arc distance of 1,121.26 feet to a point on the Existing Easement, the same point being the Point of Beginning.


Said parcel containing 23,331.13 square feet, or 0.53 acres more or less, of New Right-of-Way for roadway and utility improvements.
