# MISCELLANEOUS DISCUSSION

<u>Parking Across Sidewalks</u>. Ms. Ann Gallagher, 2513 Woodsong Drive, said not enough is being done to stop parking across sidewalk which blocks access to children who then have to go into the street to walk. She said this also creates issues for people who are in wheelchairs.

Rule of Statutory Construction. Mr. Steve Ellis, 633 Reed Avenue, said the Legal Department explained the rule of statutory construction in the text file for Item 31, Administrative Delay Appeal for 1209 Dustin Drive. He said this raises the question of how can the City square this observation about how to understand the statutes and their meaning with this interpretation of the minimum district area provision of the Planned Unit Development (PUD) ordinance. He said if a PUD can be as small as 0.67 acre, then the wording the minimum district area provision of the ordinance is clearly completely mooted. # City Manager's Report

<u>April Sales Tax Collections</u>. The general purpose sales tax remittance for the month of April (reflecting sales during February) was \$4,611,557. This is a decrease of \$48,926 (-1.05%) below 2016 levels. Fiscal year 2016-2017 sales tax receipts are now 4.14% below prior-year levels. Cities in our state, sales tax is the primary source of revenue for day to day expenses such as police and fire protection, and parks and street maintenance.

# NORMAN FORWARD PROJECTS

<u>Westwood Tennis Center Expansion</u>. Staff has received proposals for architectural services for the indoor courts, the final phase of the project. Interviews will be scheduled next week, followed by a contract for council consideration.

Final walk through with the contractor was completed this past week for the outdoor court project; and that part of the project is now completed and final payment authorized this evening. A separate contractor removed the remaining pipe rail fence and will place sod on the remaining bare areas around the courts from this project and the waterline replacement project that went on at the same time.

<u>East Branch Library</u>. The groundbreaking to mark the start of the major construction of the new East Branch library will be Wednesday, April 12th, at 9 a.m. during National Library Week. The 2017 theme for the National Library Week is "Libraries Transform."

<u>Public Art at East Branch Library</u>. Submissions for public art for the East Branch Library will be presented to the Selection Committee for final section on Friday, April 28. A recommendation for contract award for the winning art piece will then be submitted to the City Council for final approval.

<u>Griffin and Reaves Park Sports Complex Projects</u>. The Griffin Park Ad Hoc Group held their first meeting on Thursday, March 30th. The next meeting will be Thursday, April 27th, at 3 p.m. in the west conference room in Building C at the Norman Municipal Complex. The Reaves Park Ad Hoc Group is currently scheduling their first meeting.

Westwood Family Aquatic Center. A new timeline for completion of the \$12 million Westwood Family Aquatic Center puts finalization of the project at the end of the 2017 swim season. The project originally targeted a July 1 date for substantial completion, based on cooperative weather conditions. Rain and cold temperatures early in the construction of the project, coupled with recent heavy rains, have pushed completion estimates for the aquatic center to the end of August, past the 2017 summer swim season.

All possible options have been reviewed with the Westwood Ad Hoc Citizens Advisory Group, who agreed with the decision to postpone the opening until the 2018 season.

The operating hours of the splash pads at Andrews and Colonial Estates Parks will be extended this summer to allow families more water fun time since the aquatic center will not be open. The splash pads will be set up to operate from 10 a.m. to 8 p.m. every day from Memorial Day weekend through September. Discounted 2018 season passes to the new aquatic facility will also be offered later this summer.

## City Manager's Report, continued:

Water Treatment Plant. Bids were opened for the Phase II project at the Water Treatment Plant last week. Three bids were received and the apparent low bidder was from Foley Company, Kansas City, MO. The bid with alternates totaled \$29,990,165. The next lowest bidder was just over \$32 million. In January of this year, the Norman Utilities Authority received authorization from the Oklahoma Water Resources Board to borrow \$31 million from the State Revolving Fund. The contract, bid, bonds, and documents are expected to on the May 9 City Council agenda.

The Water Treatment Plant Phase II project upgrades the water treatment plant which is the workhorse of the City's water system, providing more than half the total water used by the community. Residents rely on this facility to meet their daily water demands. Improvement to the treatment processes will enhance water quality to provide better tasting drinking water. The upgrade will also implement technologies to improve safety for employees and the community, and repair aging infrastructure. Norman's existing treatment plan was built in 1965. The Phase II project will increase operational efficiency. The upgrade will also ensure that the City of Norman complies with Oklahoma Department of Environmental Quality (ODEQ) disinfection regulations.

This project is one of the capital improvements funded by the water rate increase approved by voters in January 2015.
