<u>DISCUSSION REGARDING THE FOLLOWING OUTSIDE AGENCIES FUNDING</u> REQUESTS FOR FYE 14

<u>Cleveland County Historical Society</u> – Mr. Maddux made presentation.

- Society is asking for \$200 increase for FYE 14 for a total of \$31,700.
- Society is working on a historical book of Norman that will be available to purchase in November 2013.

<u>Firehouse Art Center</u> – Douglas Shaw-Elder, Executive Director, made presentation.

- Firehouse Art Center is asking for \$60,000 for FYE 14, same amount as this year.
- The agency offers programs that change the community and the children's programs are free.
- Firehouse is asking for more corporate sponsorships.
- In FYE 2017 Firehouse will pay 100% of the utilities that have been paid by the City, estimated to cost \$25,000 per year.
- Plans are to replace heat and air system this fiscal year with freed-up bond funds.
- National Arts Council grants funding is approximately \$29,000 per year.

<u>Kiwanis Kruiser (Aging Services)</u> – Kathleen Wilson, Executive Director, made presentation.

- Recent repairs to the van depleted funds: windows were blown out during storm and lift was not working properly.
- Seniors are being taken shopping more often.
- Seniors are paying more per ride.
- Aging Services are asking for \$2,000 more for a total of \$9,500.
- Could Kiwanis provide more funding?
- Kovach wants funding level to return to 2009/2010 level which would be \$10,000 \$11,000.
- Could there be an addendum to FYE 13 budget, since repair costs were high.
- Mayor asked for a letter from the agency with explanation of why they asking for additional funds for this year.

<u>Center for Children and Families</u> – Katie Fitzgerald, Executive Director, made presentation.

- The three main activities of the CCFI are to heal abused/neglected children, strengthen families, and operate the neighborhood centers.
- The agency is asking for an additional \$10,000 for a total of \$100,000 for FYE 14.
- CCFI is seeking \$3,000,000 through private donor support to construct a new facility.
- They expect a couple of grants to roll-off this year.

<u>Sooner Theatre, Inc.</u> – Jennifer Heavner-Baker, Executive Director, and Nicki Kraisky, Business Manager, made presentation.

- Facility has new ramp inside.
- Theater gave 80 scholarships this year valued at \$30,000 which is double last year.
- Second space on Main Street is at capacity and Sooner Theatre is looking for growth options for facility.
- Gallagher asks if Oklahoma State Historical Society funds might be available for the theater.

89er Day Parade – Mr. Hollingsworth was not present due to illness.

- Committee is requesting \$5,000 for FYE 14, same as this year.
- Mayor asked if Cleveland County Fair Board can be a partner with parade instead of expense. Letter will be sent requesting information.

<u>Social and Voluntary Services Commission</u> – Teresa Capps, Commission Chair, made presentation.

- SVSC is requesting \$150,000 funding for FYE 14, same as this year.
- The all-volunteer commission is a steward of the City as they audit the various non-profit agencies that receive City funds.
- Discussion was held of the United Way contributions from City employees and whether the City could match them or not.

<u>Performing Arts Studio</u> – No presentation made.

• The agency is requesting \$3,000 funding for the FYE 2014 year, an increase of \$300.

- Qualifications specified in RFP ask for types of services provided by firm; past experience; and mandatory qualifications.
- Cost proposal is a separate component.

- Cadillac plan in 2018 concern
