MISCELLANEOUS DISCUSSION

Postponement of Items 41 and 42 Ms. Jayne Crumpley, 423 Elm Avenue, said Items 41 and 42 had been postponed a number of times and asked what the limit was for postponements. She said it was her understanding that only one notice goes out to property owners within the notification area and even though projects are postponed, no further notice is given. She said this did not seem right and she did not know if this notice gives the property owner any information about calling to make sure an item was not postponed and what steps are to be taken. She said this was not a fair or sufficient notice especially with no follow-up.

Mr. Ed Kessler, 1510 Rosemont Drive, said he would like to understand a little better why these items are proposed and then postponed. He asked if the items that were postponed tonight were proposed for a high-rise building. He asked why Council accepts these postponements and why there is no discussion.

Ms. Mary Francis, 850C Cardinal Creek Condos, said this is the fifth postponement for these items and people are getting tired of coming to the meetings each month to defend their homes and neighborhoods. She urged Council to deny this proposal and make the applicant wait until the new ordinance is in place.

Miscellaneous Discussion, continued:

Postponement of Items 41 and 42, continued

Mr. Scott Williams, 614 South Lahoma Avenue, said he would be unable to attend the June 11th, City Council meeting and wanted to voice his support of this project and for further high-density proposals for the Norman Core Area. He said the Campus Corner proposal looks to be architecturally well designed, well-located for livability, and well-scaled for the proposed location and the adjacent neighborhoods. He said he lives in the Chautauqua Historical District in Ward Four and is pro-preservation, pro-neighborhood, and pro-historic substance. He teaches Architecture and Landscape Architecture at the University of Oklahoma and moved into the Norman Core Area so that he could walk and bike to work, shop, and to attend entertainment venues. He felt that high-density in a core area neighborhood enhances the livability, vibrancy, and viability of the City. He said the Campus Corner proposal would be a great economic and residential boost for the area and the project has all the amenities or pluses that a resident would want and the architects and planners were very sensitive to all of the concerns. This was not just a single high-rise, but nicely scaled, fronts the streets and sidewalks, and has covered off-street parking with ground floor street-front commercial use with upper story living. He believed it would attract a higher income type of resident and will upgrade the area. He said he attended a meeting on May 13, 2013, and it was spoken that there was a consensus that people do not want this project in that area. He said he is not part of this consensus.

Mayor Rosenthal said Items 41 and 42, a proposal for construction of a five-story building, were postponed at the request of the applicant. She said it was a long-standing practice of City Council to allow applicants to control when their proposal will come before City Council. She sympathized with the frustration of many who have come to meetings on multiple occasions to find out the item in question would be postponed and agreed it was extremely frustrating. She said she would be asking Council to revisit this practice in the future to decide the appropriate policy for postponements. She supported the motion to postpone because that is the tradition and if the practice is going to be changed, it should be deliberated.

Norman Music Festival. Mr. Bobby Stevens, Post Office Box 6226, thanked everyone for coming to the Norman Music Festival which had been a great success. He said the area where it was held had been very nice and clean. He appreciated Mayor Rosenthal for being there to open the festivities.

\* \* \* \* \*

Wall on East Main Street. Mr. Bobby Stevens, Post Office Box 6226, thanked those who painted and cleaned up the wall he had asked about on East Main Street because it looked much better. He suggested installing curbs in front of the vacant space.

***City Manager's Report***

***Recognition of Sanitation Division.*** Recognition is given to the Sanitation Division who completed five weeks of Spring Cleanup. Crews collected over 980 tons of materials which goes a long way to keeping Norman beautiful.

***Update of Manufactured Fertilizer Ordinance.*** Staff is making good progress in implementation of the Manufactured Fertilizer Ordinance. There are six major retailers and farm and ranch suppliers in the community that Staff has contacted about the display of informational brochures as well as point of sale display boards. Four retailers have approved the information which will be displayed and two retailers are waiting for corporate approval. Staff is in the process of registering commercial applicators.

***Comprehensive Transportation Plan Subcommittee Meeting.*** The last Comprehensive Transportation Plan Subcommittee meeting will be held at 6:00 p.m., Thursday, May 23rd, at Norman High School and a report will then be provided to Council.
