The purpose of this memorandum is to notify you that the Hazard Mitigation Grant Program (HMGP) project for the City of Norman's individual safe room reimbursement program for approximately 400 primary and 200 alternate individual safe rooms, has been cleared with conditions under the National Environmental Policy Act (NEPA). The Code of Federal Regulations, 44 CFR Part 10, requires that the Federal Emergency Management Agency (FEMA) take into account environmental considerations when authorizing or approving major actions. This project has been determined to be categorically excluded in accordance with 44 CFR Part 10.8(d)(2)(xvi) from the need to prepare either an Environmental Impact Statement or Environmental Assessment. ### V. Environmental Review Project Conditions

General Comments: None Project Conditions:

- 1. In the event that archeological deposits, including any Native American pottery, stone tools, bones, or human remains are uncovered, the project must be halted immediately in the vicinity of the discovery, and all reasonable measures must be taken to avoid or minimize harm to the finds. The applicant must secure all archeological findings and restrict access to the sensitive area. The applicant must inform FEMA immediately, and FEMA will consult with the State Historic Preservation Office (SHPO). Work in sensitive areas must not resume until consultation is completed and until FEMA determines that appropriate measures have been taken to ensure compliance with the National Historic Preservation Act (NHPA) and its implementing regulations.
- Any safe rooms that are constructed more than 100 feet from an existing residential structure must be resubmitted to FEMA for re-evaluation before work begins.
- 3. The home owners at 480 Elm Avenue; 905 S Lahoma Avenue; 620 E Main Street; 501 E Main Street; 213 E Acres Street; 524 W Comanche Street; and 627 Jenkins Avenue must install their safe rooms in the manner described to FEMA and SHPO. Any changes to the installation plans for these safe rooms must be submitted to FEMA for re-review prior to the start of construction.
- 4. Unusable equipment, debris and material shall be disposed of in an approved manner and location. In the event significant items (or evidence thereof) are discovered during implementation of the project, applicant shall handle, manage, and dispose of petroleum products, hazardous materials and toxic waste in accordance to the requirements and to the satisfaction of the governing local, state and federal agencies.
- If any asbestos containing materials, lead based paint and/or other hazardous materials are found during remediation or repair activities, the applicant must comply with all federal, state and local abatement and disposal requirements under the National Emissions Standards for Hazardous Air Pollutants (NESHAP).
- 6. For safe rooms in the floodplain, applicant must coordinate with the local floodplain administrator and obtain required permits prior to initiating work. All coordination pertaining to these activities and applicant compliance with any conditions should be documented and copies forwarded to the state and FEMA for inclusion in the permanent project files.
- Applicant must prepare and provide Public Notice in line with 44 CFR Part 9.12(e) issued 15 days prior
  to the start of construction of any final decision where proposed floodplain or wetland project is the only
  practicable alternative.
- 8. The applicant is required to obtain and comply with all local, state and federal permits, approvals and requirements prior to initiating work on this project.
- 9. Changes, additions, and/or supplements to the approved scope of work which alter the existing use and function of the structure, including additional work not funded by FEMA but performed substantially at the same time, will require re-submission of the application prior to construction to FEMA for re-evaluation under the National Environmental Policy Act.
