SUBJECT: Change Order #5 – Norman Public Library East

City Council Resolution R-1112-55 grants administrative authority to the City Manager to approve change order requests up to \$40,000 or 10% of contract amount, whichever is less, and subsequently report those approvals to the City Council. Attached is a Change Order Summary and quote for a change regarding a credit for revising the scope of work related to the deletion of a sidewalk on the east side of the project site due to future work anticipated as part of the Alameda St. widening project, enhanced and increased durability for finishes on the panels for the 24 hour library canopy and enhanced durability and ceiling trims for the building interior. No additional weather/work delay days are being requested in this Change Order.

Due to the ongoing Norman Public Library East Project, a change order is being requested by Globe Construction Company in the amount of \$6,476. This change order has been reviewed and is being recommended by the project architect, Meyers, Scherer and Rockcastle, Ltd. (MSR), and has been further reviewed by the NORMAN FORWARD program management firm, ADG. An accompanying Memo from both firms is included in the back-up documentation.

The work for this Change Order is being done to provide a credit for the deletion of sidewalk on the east side of the project drive. This sidewalk would extend east of the driveway into the project, but will ultimately be taken out and replaced when the Alameda Street widening project takes place. Since the exact alignment of that project is not known at this time, placement of the sidewalk (if installed) may change. Since the sidewalk ultimately does not connect to any additional sidewalks extending east, it is not critical for pedestrian access. The sidewalk on the west side of the drive is being installed and will connect to an adjacent sidewalk to provide pedestrian access. Other work included in the this Change Order is for enhanced finishes to increase durability for the ceiling trim, 24-hour library canopy panels and infrastructure within the building for both public use and library staff operations.

We have reviewed the change order with both MSR and ADG to confirm that the items listed therein are acceptable. At this time, we recommend approval of the change order from Globe Construction Company in the amount of \$6,476. Funding is available in account number 51-9507-455.6101 - Project NFB 017.

The descriptions below are intended to explain the reasons for each change stated in CO #005, and the associated costs for each change. Reference CO #005 for the formalized and signed document outlining these changes. Reference the potential change orders produced by Globe Construction for the origination of stated costs.

PCO 017 - City Right of Way - (-\$2,035.00) credit

Explanation: Work to include items revised in order to appropriate the widening of the city right of way along E. Alameda Street, based on City of Norman plans. The credit in this order pertains to a substantial revision to the scope of sidewalk include near the street. MSR recommended.

PCO 018 - 24 Hour Library Panel Finish - \$2,721.00

Explanation: Work and material to provide a better finish on the exterior of the 24 Hour Library canopy. Kynar metal finish (superior finish due to its integral color property) has been selected in lieu of the inferior black aluminum that was offered at base bid, which was originally chosen due to budget concerns during value engineering. MSR recommended.

PCO 020 - Ceiling Trim - \$5,790.00

Explanation: Material clarified to provide consistent and durable trim installation with added overall value at all ceiling plane perimeters and undulations. Work to include the addition of a bulkhead to capture an unanticipated conflict with the ceiling at the mechanical duct stemming from the FCU-7 unit. MSR recommended.
