She said she is not opposed to more diverse neighborhoods; but it should be done more intentionally. She said she wants neighborhoods to be preserved while at the same time encouraging accessible housing. She is not opposed to duplexes in neighborhoods but would rather have a more holistic approach to any decisions made

410, 414, and 416 North Park Drive, continued. Mayor Miller said she wished a solution could be worked out for accessible, affordable housing. She said she wished answers could be found for both because they needed to go together.

<u>Saving Suburbia</u>. Mr. Evan Dunn, Citizens Solutions, 1400 Garfield Avenue, said he wants to work to save suburbia. He said there is data about energy consumption and oil extraction and projections can be made from this information. He said he has done live broadcasts on Facebook to allow him to articulate his ideas and to have a record of these ideas. He says when he goes to public places, he asked people why they are grateful.

*

<u>Plastic Bag Issues</u>. Mr. Larry Steele, 730 Hoover Street, said there was an article recently in the *Norman Transcript* about a study Councilmember Clark did about plastic bags. He said the plastic bags that are hanging on fences trees are disgusting. He said Councilmember Clark has taken the lead in this and thanked her. He hoped Council would support what she is doing. He displayed sample bags he brought from home that he keeps in his car to use in lieu of plastic bags. He encouraged the City of Norman to be a leader in the state by getting rid of plastic bags. He said there should be recycling in the stores for used plastic bags. He also suggested a \$.05 deposit on each plastic bag.

Councilmember Clark said she had been given too much credit for the progress on plastic bags. She said Mayor Miller came with her on the tour and Councilmember Holman had already been on the tour. She talked to Councilmembers Karjala and Hickman over a year ago and Councilmember Allison got involved too. She said all of Council had discussed this at the City Council retreat in August. She was more vocal because she sat on the Oklahoma Municipal League Legislative Committee. She felt like she had been slapped in the face when Senate Bill 1465 came out preempting cities from local control and Norman was specifically mentioned. She said this is a priority for all of us and if we do not act sooner than later, we may be pre-empted. She said there have been comments about it on Facebook and the *Norman Transcript* did an excellent article. She said it has not been heard in committee yet and her goal is that this happens during the summer. She hoped there would be a lot of community feedback. She knows people are not happy with a fee but what if this fee pays for recycling in east Norman, commercial, multi-family or churches.

Councilmember Allison said he was passionate about Councilmember Clark's poster making in different places in the community that are using recycled bags. He looked up what it costs to buy a biodegradable bag. He does not use plastic bags in his business and did not know the impact. He said he has not talked to any business owner who was against using recycled bags. He said a case of plastic bags costs \$14.84 per case and a case of biodegradable gas cost \$16.49 per case. He said this is a small cost and the business community is not going to be against doing this.

*

Accessible Public Transportation. Mr. John High, 1705 Dakota Street, said in the past, he would not have been able to attend this Council meeting because there was no bus available at that time to take him home. He said he now has transportation but the person he is speaking for does not. He said many would like to go to church on Sunday but cannot because buses do not run on Sunday. He said taxis are supposed to provide accessible transportation but no one enforces the law to make them do it.

<u>Homeless People Camping on Private Property</u>. Mr. Roger Gallagher, 2513 Woodsong Drive, said for several years Mr. Will Mattoon has had the problem of homeless people camping on property he owns and they leave trash on the property. He said Mr. Mattoon takes care of this property as the land owner. He said this trash being left on the property creates a health hazard and he does not see why the City cannot look at trying to resolve this problem. He said some cities have an open area where homeless people can camp out.

<u>Sculpture at New Central Library</u>. Mr. George Ahmadi, 502 North Park Avenue, said he loved the sculpture that will be placed in front of the new Central Library.

Central Oklahoma Master Conservancy District (COMCD). Councilmember Castleberry said he had the privilege of attending the COMCD meeting on Thursday, May 3rd,. on behalf of the Mayor. He said he delivered a letter from the Mayor asking Midwest City and Del City to postpone their request to not participate in a reuse program. He said the State of Oklahoma is recognizing reuse as a way to conserve water. He said it is disheartening that Midwest City and Del City are opposed to the City of Norman putting cleaner water in Lake Thunderbird because they cannot process the cleaner water that they get out of the lake. He said the City of Norman is doing all the work and plans to pay for it. He said these two cities do not use Lake Thunderbird as much as the City of Norman does. The City of Norman has three voting members and Midwest City and Del City have two voting members each. They are outvoting the City of Norman, 4-3. These two cities have requested that Norman make a presentation to each of their city councilmembers at a Council meeting.

Councilmember Holman said he and the Mayor served on the 2016 Strategic Water Supply Committee for over two years and looked at a lot of different options for addressing Norman's water use needs. He said reuse was clearly the only viable option. He said the City of Norman dumps about 10,000,000 gallons per day of treated wastewater into the Canadian River, which goes downstream and is used by other communities. He said reuse will allow some of the water to go into the lake. He said all water is reused and technology allows the water to be cleaned and purified. He said buying water from Oklahoma City is extremely expensive and there would be no control over water rates if we purchased all of our water from Oklahoma City. He would be happy to go to the City Council meetings in Midwest City and Del City to support reuse.

*

<u>Public Hearing on the Budget</u>. Councilmember Castleberry said the public hearing on the budget is May 22nd. He said there is a \$2,000,000 shortfall and encouraged more than three people to speak at the public hearing. He said this is a major issue and Council needs the public's input.

Councilmember Hickman said it is a significant problem. He said in the last two years, there has been \$5,000,000 more in expenditures than revenues.

Oil and Clay. Councilmember Hickman said on Thursday, May 10th, please come to Oil and Clay, 410 East Main Street, to a pet portrait workshop.

Councilmember Hickman said the Community Planning and Transportation Committee meeting would be held on Thursday, May 24th, at 4:00 p.m. He said this committee pushed forward a pilot project about incentivizing developers who build energy efficient homes. He said discussion will continue about green building by discussing water efficient homes. He said discussion will continue about a tree ordinance to protect the tree canopy in Norman.

<u>Birthdays</u>. Councilmember Hickman said before the next Council meeting, Councilmember Castleberry will be celebrating a birthday on May 14th and Councilmember Karjala will have a birthday on May 16th. He asked for a round of applause for both of them.

She said it is important for everyone to get out and meet these candidates and get to know them better.

Future of Our Water.

- Part of Norman's long-term water plan is to recycle water from our Water Reclamation Facility
- Supplementing the lake with highly-treated water from the plan is called Indirect Potable Reuse (IPR)
- IPR is not new, it is proven technology in use in eight other states some for as long as 40 years
- Norman will be conducting a pilot study as part of our focus on assuring the safety and quality of our water

How Indirect Potable Reuse Would Work in Norman.

- Central Oklahoma Master Conservancy Board manages Lake Thunderbird for the three cities for which is supplies drinking water Norman, Midwest City and Del City
- At last week's board meeting, Del City submitted a resolution to the Board to disallow the addition of the highly-treated reuse water into the lake.
- Norman asked the Board to postpone a decision and allow us to present information about the technology. The Board voted 6-1 to postpone voting on the resolution until the August meeting to allow for the presentation.

How Indirect Potable Reuse Would Work in Norman, continued.

- CM Castleberry: "Augmentation of Lake Thunderbird with highly treated indirect potable reuse water is an important part of Norman's long-range water supply plan and, so far, indications are that it could help drought-proof the lake for all three cities, as well as improve the quality of the water in the lake," Norman Mayor Pro Tem Robert Castleberry said. "Stopping the study of indirect potable reuse as a possibility for the lake is not in keeping with the obligation of COMCD to provide sufficient water."
- Mayor Miller's Letter: As stated in each city's contract with COMCD, the very purpose of the Lake Thunderbird project was to provide for a municipal water supply for the participating municipalities of Del City, Midwest City, and Norman. It is the Board's duty to ensure sufficient water is provided. ...Just like COMCD, Del City, and Midwest City, Norman has a vital interest in implementing measures that reduce the vulnerability of Lake Thunderbird to drought and improve the firm yield, maintaining the lake as a reliable resource for our community's water supply. ...Multiple engineering studies done for COMCD since then have identified augmentation of the Lake with treated wastewater discharges (the "augmentation project") to be the most feasible solution to COMCD's supply problem. Potable reuse provides COMCD a locally controlled, drought-proof water supply.

Water Reclamation Facility:

- Facility turns 75 this year
- The three-year construction project is complete so we are hosting an Open House and tours for customers on May 18th at 9:00 a.m.
- \$63 million expansion, approved by voters in 2013, increased the capacity from 12 MGD to 17 MGD using a low interest State Revolving Fund loan

The expansion project also allowed the City to meet state and federal requirements and to discharge treated wastewater that is better for the environment. It included odor control measures to greatly reduce odors from the plant as well as emergency generators to keep the plant operating during outages.

Development Activity. The City of Norman recently received a building permit application for renovation of the former Holiday Inn, Norman Hotel. the hotel owner is working through Marriott and there are plans for a Delta Hotel by Marriott – a brand started in Canada and it has recently made its debut in the United States.
