O-1819-3 – St. Thomas More Church requests closure of a 5' wide by 134' long utility easement located at the northwest corner of Lot 1, Block 1, St. THOMAS MORE CHURCH ADDITION.

PRESENTATION BY STAFF:

1. Ken Danner reviewed the staff report, a copy of which is filed with the minutes. Since there are no utilities within this portion of the utility easement that are in conflict with the proposed building, staff is not opposed to closing a portion of the five-foot (5') utility easement.

PRESENTATION BY THE APPLICANT:

Harold Heiple, representing the applicant – If you have your page 6-1, it's got a location map in front of you. If you'd refer to it, I can make, I think, quick explanation. The portion designated "subject tract" in black bold hexagon, is the original plat of St. Thomas More Addition that was platted in 1977, as I recall. That dotted line is the west half of a 5' wide utility easement that was dedicated on that original plat as a utility easement, and only this half is requested to be closed, because the east half actually does contain utility lines, which come up Lincoln Street, then turn back west up to the boundary of the existing church building, then go back north to Stinson. So we only ask to close this 134' for this reason. We're in the process of building a new church in the undeveloped land right adjoining on the south of the existing church, and the plan is to connect those two structures by roof and walls and windows. They will be connected. You cannot build a structure on an easement, so that's why we have to ask that it be closed. That's in a nutshell what we're here for. I've been doing this for 55 years. I have a lot of easements and a lot of consents to encroachment. I've never had one that was cleaner, more unopposed, and more beneficial than this particular one. In light of the fact that this is my last appearance before the Planning Commission, I would hope it gets a unanimous vote. Thank you.
