Project Goals:

To reduce the number of fatalities and serious injury crashes in the city of Norman through targeted traffic enforcement efforts.

To limit a projected increase in the number of traffic fatalities statewide from 687 in 2016 to 699 in 2019, to decrease the number of Serious Injuries in traffic crashes statewide from 2,788 in 2016 to 2,701 in 2019, and to decrease the number of fatalities involving a driver/operator .08 or more BAC from 181 in 2016 to 139 in 2019.

Problem Identification:

The population of Norman is approximately 120,000 plus the student population of the University of Oklahoma. The City is also approximately 190 square miles and includes both suburban and rural areas. The City boasts the University of Oklahoma, Lake Thunderbird State Park, multiple convention venues, and sporting events. I-35 and SH 9 both intersect the City with traffic traveling at highway speeds. According to 2016 data provided by the Oklahoma Highway Safety Office, the City of Norman is above the state rate for Alcohol-Related KA Crashes, Unsafe Speed KA Crashes, Motorcyclist KA Injuries, and KA Crashes involving drivers distracted by something other than an electronic device, all per 100 million vehicle miles traveled. Additionally, 3 occupants died while unrestrained. According to the City of Norman alcohol-related crashes and KA crashes have decreased since 2012. In an effort to maintain recent improvements in reducing crashes, the Norman Police Department will need additional funding to target specific traffic safety issues that contribute to KA crashes in their jurisdiction.

Project Description:

The Norman Police Department will conduct high visibility enforcement in support of State and National goals to reduce the incidence of KA crashes in their community. Officers will work in an overtime capacity to identify those violations that cause or contribute to KA crashes. To identify those times and locations where KA crashes most often occur, the Project Director will utilize all data and reference sources available including crash reports, public complaints and other crime statistics. DDACTS will assist to locate geographically based patrol zones in order to identify high-crime and high-crash enforcement areas. Traffic Officers and Bike

Team Officers will also focus on areas that include increased numbers of pedestrians and bicyclists. The City of Norman has a high student population that utilizes these modes of transportation and increases the likelihood for crashes as they share the road with motorists. Enforcement activities will encompass traffic laws as they apply to pedestrians and bicyclists, with officers working during times and in areas having the highest concentration of bicycle/pedestrian traffic.Officers will conduct high visibility enforcement in the identified areas. In the high visibility enforcement model, officers focus on drivers who commit common aggressive driving actions such as speeding, following to closely, and running red lights. Efforts may also include impaired driving enforcement, occupant protection enforcement and related activities such as traffic safety and sobriety checkpoints. Saturation patrols may be conducted with a primary focus on those violations that may cause or contribute to KA crashes. Preliminary breath test devices (PBTs) may be utilized during special events such as "Know Your Limit" as well as OHSO mobilizations. Public information and education activities will inform and educate the public during special emphasis days and times. Presentations by School Resource Officers and Bicycle Team members will also serve to educate bicyclists and pedestrians of the laws and regulations regarding their safety.

Funding is provided for specifically focused alcohol-impaired driving enforcement strategies. Efforts will include targeted enforcement and related activities such as saturation patrols and sobriety checkpoints especially during local emphasis efforts such as "Operation Cadence", "No Refusal Weekends", holidays and OHSO mobilizations.

In addition to the above, in agreement with the Oklahoma Department of Mental Health and Substance Abuse Services and in accordance to the Memorandum of Understanding and Statement of Work attached to this grant agreement, the Norman Police Department will also conduct targeted alcohol compliance enforcement as set forth in said MOU and SOW in support of the NHTSA goal to target violations which contribute to alcohol-related motor vehicle crashes.

Not all KA crashes and injuries can be directly attributed to a specific primary causational factor. Some crashes occur because drivers operate a vehicle unsafely, without due attention to traffic laws and road conditions. General traffic enforcement is intended to allow agencies to address a greater variety of traffic violations, dependent upon local problem identification.

The Norman Police Department will employ the following evidence-based strategies in conducting grant related activities:

High Visibility Enforcement
Publicized Sobriety Checkpoints
Public Information and Education Supporting Enforcement
Preliminary Breath Test Devices
Minimum Legal Drinking Age Enforcement
Alcohol Vendor Compliance Checks

General Provisions - Part II

REGULATIONS AND DIRECTIVES

The Grantee, its assignee(s), successor(s) in interest, subcontractor(s), supplier(s), or anyone who is a recipient of financial assistance through this grant shall agree to all applicable provisions of the following; however, nothing here should be interpreted to limit the requirements to comply with regulations and directives not included in this list:

L. 101-336), as amended (42 U.S.C. 12101, et seq.), which prohibits discrimination on the basis of disabilities (and 49 CFR Part 27); (d) the Age Discrimination Act of 1975, as amended (42 U.S.C. 6101-6107), which prohibits discrimination on the basis of age; (e) the Civil Rights Restoration Act of 1987 (Pub. L. 100-259), which requires Federal-aid recipients and all subrecipients to prevent discrimination and ensure nondiscrimination in all of their programs and activities; (f) the Drug Abuse Office and Treatment Act of 1972 (Pub. L. 92-255), as amended, relating to nondiscrimination on the basis of drug abuse; (g) the comprehensive Alcohol Abuse and Alcoholism Prevention, Treatment and Rehabilitation Act of 1970 (Pub. L. 91-616), as amended, relating to nondiscrimination on the basis of alcohol abuse or alcoholism; (h) Sections 523 and 527 of the Public Health Service Act of 1912, as amended (42 U.S.C. 290dd-3 and 290ee-3), relating to confidentiality of alcohol and drug abuse patient records; (i) Title VIII of the Civil Rights Act of 1968, as amended (42 U.S.C. 3601, et seq.), relating to nondiscrimination in the sale, rental or financing of housing; (j) any other nondiscrimination provisions in the specific statute(s) under which application for Federal assistance is being made; and (k) the requirements of any other nondiscrimination statute(s) which may apply to the application.
- 3. Hatch Act (Political Activity), 5 U.S.C. Sections 1501-1508 and 5 CRF Part 151.
- 4. Buy America Act, 23 U.S.C. 101.
- 5. Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion Lower Tier Covered Transactions:
 - (1) The prospective lower tier participant certifies, by submission of this proposal, that neither it nor its principals is presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from participation in this transaction by any Federal department or agency.
