Know all men by these presents:

That Alameda Land Company, L.L.C., in consideration of the sum of One Dollar (\$1.00), receipt of which is hereby acknowledged, and for other good and valuable considerations, do hereby grant, bargain, sell, and convey unto the City of Norman, a municipal corporation, a public utility easement and right-of-way over, across, and under the following described premises situated in the City of Norman, Cleveland County, Oklahoma, to wit:

A strip, piece or parcel of land lying in part of the SW¼ NW¼, Section 34, Township 9 North, Range 2 West, I.M., Cleveland County, Oklahoma. Said parcel of land being described by metes and bounds as follows:

Commencing at the Southwest corner of said SW¼ NW¼, thence N 00°25'06" W along the West line of said SW¼ NW¼ a distance of 986.61 feet, thence S 89°59'46" E a distance of 50.00 feet to a point on the permanent East right-of-way line of 24<sup>th</sup> Avenue SE, said point being the point of beginning, thence continuing S 89°59'46" E a distance of 11.00 feet, thence S 00°25'06" E a distance of 328.76 feet, thence S 89°35'01" W a distance of 11.00 feet to a point on said permanent East right-of-way line, thence N 00°25'06" W along said permanent East right-of-way line a distance of 328.84 feet to the point of beginning.

Containing 3,617 square feet or 0.08 acres, more or less.
