TEMPORARY CONSTRUCTION EASEMENT

Know all men by these presents:

That Alameda Land Company, L.L.C., of Cleveland County, State of Oklahoma, for and in consideration of the sum of Ten Dollars (\$10.00) and other good and, valuable consideration, has/have this day sold to the City of Norman, a temporary easement over the following described land to wit:

A strip, piece or parcel of land lying in part of the SW¼ NW¼, Section 34, Township 9 North, Range 2 West, I.M., Cleveland County, Oklahoma. Said parcel of land being described by metes and bounds as follows:

Commencing at the Southwest corner of said SW¼ NW¼, thence N 00°25'06" W along the West line of said SW¼ NW¼ a distance of 986.61 feet, thence S 89°59'46" E a distance of 61.00 to the point of beginning, thence continuing S 89°59'46" E a distance of 6.00 feet, thence S 00°25'06" E a distance of 328.71 feet, thence S 89°35'01" W a distance of 6.00 feet, thence N 00°25'06" W a distance of 328.76 feet to the point of beginning.

Containing 1,969 square feet or 0.05 acres, more or less.

All bearings contained in this description are based on the Oklahoma State Plane Coordinate System and are not astronomical bearings.

With the right of ingress and egress to and from the same, for the purpose of surveying, laying out, constructing, maintaining, and operating a public roadway, drainage structure or utility.

The sole purpose of this easement is to grant to the City of Norman the right to work on the above-described tract of land, and includes the right to use and remove any and all sand, rock, dirt, gravel, and other road building materials from the above-described tract of land.

It is a condition of this easement that it shall not be filed for record and that all rights conveyed to the City of Norman by this instrument shall terminate upon completion of construction of the project.

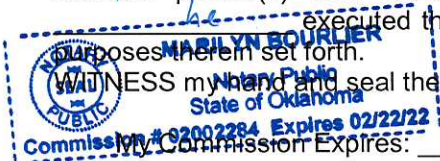
