

GRANT OF EASEMENT  
City of Norman

Know all men by these presents:

That Alameda Land Company, L.L.C., for and in consideration of the sum of One Dollar (\$1.00), receipt of which is hereby acknowledged, and for and upon other good and valuable considerations, do hereby grant, bargain, sell and convey unto the City of Norman, a municipal corporation, a public utility easement and right-of-way over, across, and under the following described real estate and premises situated in the City of Norman, Cleveland County, Oklahoma, the following described land to wit:

A strip, piece or parcel of land lying in part of the SW¼ NW¼, Section 34, Township 9 North, Range 2 West, I.M., Cleveland County, Oklahoma. Said parcel of land being described by metes and bounds as follows:

Commencing at the Southwest corner of said SW¼ NW¼, thence N 00°25'06" W along the West line of said SW¼ NW¼ a distance of 657.40 feet, thence N 89°35'01" E a distance of 33.00 feet to a point on the present East right-of-way line of 24<sup>th</sup> Avenue SE, said point being the point of beginning, thence N 00°25'06" W along said present East right-of-way line a distance of 328.96 feet, thence S 89°59'46" E a distance of 17.00 feet, thence S 00°25'06" E a distance of 328.84 feet, thence S 89°35'01" W a distance of 17.00 feet to the point of beginning.

Containing 5,591 square feet or 0.13 acres, more or less.

All bearings contained in this description are based on the Oklahoma State Plane Coordinate System and are not astronomical bearings.

With the right of ingress and egress to and from the same, for the purpose of surveying, laying out, constructing, maintaining, and operating a public roadway, drainage structure or utility.


