At the January 15, 2019, Council Study Session, staff will be presenting an update on land acquisition of the North Base Facility for the Senior Center, Indoor Aquatic Facility and Indoor Multi-Sport Facility as part of the Norman Forward program.

Additional Project Considerations

- Site due diligence activities will include:
 - Phase I Environmental Assessment of the site
 - Solicitation of proposals for demolition of Optimist Gym facility/gym demolition
 - Other site discovery and infrastructure planning activities

Additional Project Considerations

- Traffic and drainage infrastructure costs are separate budgeted costs in the Norman Forward program.
- Project scope, timing and design of these improvements for the areas around the North Base site will be assessed as the Master Plan is developed and completed.
- Infrastructure construction is anticipated to coincide with completion of the facilities.



Additional Project Considerations

- Discussions with operational partners (Norman Public Schools, Norman Regional Health System, YMCA, Sooner Swim Club) will be ongoing throughout the Master Plan and early facility design phases.
- Operational Agreement for the Indoor Multi-Sport Facility and Indoor Aquatic Center is anticipated to be complete prior to completion of the design of the Indoor Aquatic/Multi-Sport facilities.
- Construction Manager at Risk (CMAR) Request for Proposal/contractor selection could be timed to best coincide with facility design and expediency of construction timeline.
