MISCELLANEOUS DISCUSSION

CART Services. Mr. Rich Holtzchue, 1109 Trout Avenue, said he understood that the City of Norman was taking over the City bus routes and asked for information. Mayor Miller said if he would wait until after the meeting, City staff would provide information. She said there are ongoing discussions between the City of Norman and the University of Oklahoma and nothing has been decided.

*

Aquatic Facility. Mr. Allen Hickey, Sooner Swim Club, said members of Sooner Swim Club really want to break ground on a new Aquatic Facility. He said Sooner Swim Club is presently using the University of Oklahoma pool and the pool was shut down during the holidays. He said the facility is old and the club needs a place to practice. He said they have been able to use the YMCA a few times but it is not a pool equipped for competitive swimming.

Mayor Miller said Council is hoping to have some information in the next few weeks.

Councilmember Castleberry said because of last week's weather, the item regarding the land for the Aquatic Center would have been on tonight's agenda. He said he feels strongly that the contract for the land will be on the January 22nd agenda.

Councilmember Hickman said an update regarding the land will be presented to Council in Study Session on January 15th.

Councilmember Holman said the Aquatic Center, the Senior Center, and the Indoor Multi-Sport Facility are three NORMAN FORWARD Projects that will be able to move forward once the agreement with the University of Oklahoma has been finalized.

Helping Out the City. Mr. Evan Dunn, 1400 Garfield Avenue, said he is on the ballot for the upcoming election but he does not want to win. He said he would do the job but he would like to be the Sustainability Director, change the information on the City television channel, do urban forestry, or fill in for the Planning Director. He said he could put in 18 hour days.

Miscellaneous Discussion, continued

Charter Review Commission. Mr. Chambers, Norman, said he agreed with Councilmember Holman that having the same people on the Charter Review Commission will get the same results. He said getting some new people will be beneficial.

Mr. Steve Ellis, 633 Reed Avenue, and Mr. Harold Heiple, 2011 Morgan Drive, said they had worked together to come up with suggested language for Section 5 (j) of Resolution R-1819-66. Mr. Ellis said it could read “Consider retaining Article XVI, Section 2 of the Charter requiring a vote of the electorate prior to increasing City utility rates and adding language to specify the timing and the extent of such votes.” Mr. Ellis said the Charter Review Commission’s charge would be come up with a method through which we could get votes for utility rates on the City election date in a fairly automatic way with a procedure that looks at what the needs of the utilities are. He added this should take in account all future needs and all the things looked at when we have done our master planning. Mr. Heiple said they would prepare something in writing and submit it to Council.

Mayor Miller asked that they can submit it to her or Ms. Brenda Hall, City Clerk, so they can provide it to the rest of Council.

Councilmember Castleberry said although the members selected for the Charter Review Commission are the same people, these are not the same questions. He said he had no problem with adding people to the Committee but the people that get appointed to the committee should be qualified. He said the Committee is comprised of former Councilmembers, Legislators, etc., because these people understand the Charter and have some background in it.

Councilmember Castleberry said he had a similar solution as the one submitted by Mr. Ellis and Mr. Heiple. He really believes that the structure of the utility rates need to be reviewed every 12-18 months by a Utility Commission whose sole purpose is to look at utility rates. He said they could look at all of the utilities on a rotating basis, water one year, sewer the next year, etc. He said the Utility Commission would make a recommendation for people to vote on or the Utility Commission would vote on it and it would go to the voters. He said if the City puts something on the ballot asking if people still want it to go to a vote of the people, it does not mean Council is saying that they agree that their right to vote on utility rate increases should be taken away. The citizens should make this decision. He said the Charter Review Commission will have open meetings and they will want public input.

Mayor Miller said throughout the last several months Councilmembers have discussed a number of issues that needed to be addressed that could only be addressed with a charter amendment. She said she is committed to make sure every Councilmember has the opportunity to add suggestions for changes to be looked at by a Charter Review Commission. It does not mean we all agree with every one of them. She said at the meeting where the Charter Review Commission was discussed, she understood Council saying that the original commission would be called to serve. She said she is glad this item was postponed to allow additional discussion. She strongly recommends that the people who have agreed to serve be left on the committee and if Council wants to add more people, we can discuss it.

*

Citizen Committee for City Manager Search. Mr. Scott Martin, President/Chief Executive Officer, Norman Chamber of Commerce, 115 East Gray Street, said based on conversation in tonight’s Council Conference, there had been a lively discussion about citizen input on all things that are taking place throughout our community. He read a statement saying “The Norman Chamber of Commerce strongly encourages the Norman City Council to utilize a citizen search committee in the hiring the new City Manager.” Historically this has been the practice adopted by previous City Councils and provides a method of meaningful input from the general public as the Council considers who will be the next City Manager. A Citizen Search Committee helps open up the process and engages thoughtful citizens in this important decision. While this would have been advisable at the beginning of the process, it is not too late to do the right thing and create such a committee to help Council navigate the many applicants that will apply. Openness, transparency and citizen involvements are hallmarks of good government. The Chamber cannot think of a better time for you to show our community that you are committed to these ideals.”

Miscellaneous Discussion, continued:

Possession of Marijuana. Mr. Chambers, Norman, said marijuana is a drug and some fine should be assessed for possession but it could be lower. He said the license for Medical Marijuana is just like a Conceal and Carry license.

Councilmember Holman said six years ago when he became a Councilmember, he never thought he would be voting on decriminalization of marijuana. He said many thought Oklahoma would be the last state to address marijuana; however, he was not surprised that State Question 788 passed. He was really excited to make changes to the ordinance to address the changes.

Councilmember Scott said she had been pleased State Question 788 was passed and pleased with the Ordinance making changes to the Code. She said she feels the fines could be reduced because \$400 is a little excessive.

*

Transportation and Stormwater Bond Election. Councilmember Holman said the Transportation Bond issue has three large projects in Ward Seven, one is a combined stormwater project addressing the number one flooding problem in Ward Seven at Lindsey Street and Elm Avenue. He said it also addresses the number one transportation project which is Jenkins Avenue; this project will add bike lanes and continuous sidewalks, and Americans with Disabilities (ADA) improvements. He said Stormwater is the biggest issue, in his opinion.

Councilmember Scott said that next week her last semester of her Master's Program at the University of Oklahoma will begin. She has told Ms. Carrie Evenson, Stormwater Program Manager, that she will commit an extra hour and a half on Campus Corner on Mondays and Wednesdays to continue having the discussion about stormwater and encouraging young people to get out and vote on stormwater. She said the survey results showed a very small amount of people between the ages of 18 and 24 took the survey. She said they are not paying attention and she is committed to asking people to vote on stormwater.
