GRANT OF EASEMENT

with the right of ingress and egress to and from the same, for the purpose of surveying, laying out, constructing, maintaining, and operating:

Installation of main water line

In the event there is no active installation, using and/or maintaining said easement for a period of 180 days, the Grantor may terminate and vacate said easement by filing notice of termination with the Cleveland County Clerk. If this easement is abandoned or vacated, at Grantor's option, Grantee shall restore the Property to its previous condition at Grantee's cost. Grantee is responsible for any and all damages relating to arising from Grantee's use of this easement and repairing any damage caused to Grantor's Property by Grantee's actions during construction and thereafter. Grantee will plant two (2) trees of mutually agreeable size for every one (1) existing tree that may be damaged.

Grantor retains the right of ingress and egress to and from and across the property for uses of its own in a manner and place acceptable to Grantee, acceptance not to be withheld unreasonably.

Grantee, its successors and assigns shall keep, repair and maintain the easement granted hereunder in a proper, attractive and workmanlike manner at its sole cost. Grantee shall notify Grantor of its intent to enter the easement and the purpose therefor prior to entry, unless under emergency conditions in which case notice shall be given on the first business day thereafter.




