

**AGREEMENT FOR PROGRAM MANAGEMENT SERVICES
AMENDMENT NO. 2**

This Amendment No. 2 to Contract No. K-1516-110 is between the City of Norman, Oklahoma, a municipal corporation (hereinafter referred to as the “City”) and ADG P.C. (hereinafter referred to as the “Program Manager”).

WITNESSETH:

WHEREAS, the parties entered into Contract No. K-1516-110 on February 23, 2016 for the purpose of providing a variety of services including but not limited to facilities assessment, planning and programming, architectural and engineering plan review, design and construction coordination and construction observation services for certain upcoming City construction projects (“Program Management Services”); and

WHEREAS, the parties executed Amendment No. 1 to K-1516-110 on June 27, 2017, which added projects and costs in the amount of \$130,037 relating to Reaves Park, Griffin Park, and the Westwood Tennis enclosure.

WHEREAS, the original Contract No. K-1516-110 anticipated a 36-month term, requiring further party approval for any extension thereof.

WHEREAS, the parties have evaluated the current status of the projects originally included in Contract No. K-1516-110 and Amendment No. 1 thereto, as well as future Norman Forward needs for the City, and desire to extend the Program Manager’s provision of Program Management Services for 36 additional months for a new list of projects, including some already within K-1516-110 and some not originally within the agreement.

NOW, THEREFORE, the parties desire to amend Contract No. K-1516-110 as follows:

Substitution of Exhibits A, B and C:

Exhibits A, B and C to Contract No. K-1546-110, originally approved February 23, 2016, shall be removed by agreement of the parties and fully replaced with Exhibits A, B and C attached hereto.

Extension of Contract Term:

It is understood and agreed by and between the parties that the initial term of Contract No. 1516-110 is hereby completed and shall be extended by this Amendment No. 2 for a further term of thirty-six (36) months, subject to Section 25 of the Contract, and effective March 1, 2019 through March 1, 2022.

All other terms of Contract No. K-1516-110 shall remain in full force and effect.
