MISCELLANEOUS DISCUSSION

Item 34, Charter Review Commission. Mr. Harold Heiple, 2011 Morgan Drive, thanked City Council for postponing and supporting the motion to postpone Item 34. He said Item 34 has twelve (12) separate items to discuss and make amendments to. He asked if someone had something to add to the charter amendment, please submit to the Charter Review Commission in writing before consideration of the item and have the information published on the City website and in the newspaper so residents can keep up with the information and understand what it is.

*

Abolishment of Abortion. Mr. Shane Dodson said he is a husband, a father, and co-manager of a small business in Norman. He said he is a follower of Jesus Christ and as a Christian, he is appealing to City Council because the Bible says obey Christ. He said almost every day in the City of Norman, a man, Dr. Larry Burns, murders children under the protection of law. He says Roe vs. Wade is not, strictly speaking, law and Congress makes law not the courts. There is no interpretation that allows human beings to be legally considered to be less than human and; therefore, not worthy of a protection. He said the state of Wisconsin stood up to the Supreme Court in 1855 and protected slaves, who at that time were considered property and subhuman. He said preborn children have been legally declared subhuman and can be killed. He said the killing may be done in sterile office in nice neighborhoods by medical professionals and may even seem lawful in the eyes of citizens. He said according to the law of God and in light of nature, it is unlawful. He urged City Council to stand up to wicked federal decrees. He said if enough local magistrates stand up to the Supreme Court and declare that the murder of pre-born children will no longer be allowed within their area of authority, abortion will eventually be abolished. He said if Council is serious about this question, he would love to sit down and discuss this. He said he goes to Christ the King Presbyterian Church and his elders would also like to discuss this with Council.

Miscellaneous Discussion, continued:

Abolishment of Abortion, continued. Councilmember Castleberry apologized to Mr. Dodson because some members of City Council turned their back on him as he addressed the Council. He said he is not saying he agrees or disagrees with him but this is the public's house. He said Miscellaneous Discussion is at the end of every City Council Meeting to allow citizens to address the Council. He said all kinds of people have stood at the podium for Miscellaneous Discussion. He said Council is elected to represent the citizens and he is embarrassed that anyone would turn their back on a member of our community. He said if this is the new standard, he will be turning his back on a lot of people.

Councilmember Scott asked Councilmember Castleberry to never feel obligated to apologize on her behalf. She said she is not sorry that she turned around when Mr. Dodson talked about anti-choice legislation in the City. She thinks it is inappropriate especially because separation of church and state is in place for a reason. She said Council listens but does not have to any of the speakers' opinions into consideration when making their own decisions. She said she encouraged him to look at countries where abortions are banned and abortions are still happening but they are unsafe. She said underserved communities are disproportionately affected by it; specifically the women of color who are also low income that cannot afford safe abortions. She said this does hurt women and on a day when we have a proclamation about International Women's Day, this is extremely inappropriate. She said the safety and health aspect in women's reproductive justice should be taken into consideration as well as men's reproductive justice.

Mayor Miller said she believed that when the public elects us, they have a right to expect a certain level of courtesy and decency in the way they treat everybody, whether it is on Facebook, email, by phone, in person, or during a meeting. She said she is not sure she always sees that. Whoever comes up here to talk or comes to her office, she believes they have a right to her respect and courtesy whether she agrees with them or not. She said she does not agree with a lot of things that people say when they come up here, come to her office, when they call or email. She thinks Council has an obligation to our public to be courteous and respectful and to listen. She said that is not too much to ask.

*

CART Services. Ms. Chris Nanny, 1815 Lakehurst Drive, said she rides the bus every day in the City of Norman and has received several comments and questions from passengers and bus employees that are worried about their jobs. She asked for an update of the status of the transfer of the bus system from the University of Oklahoma to the City of Norman.

Mayor Miller said there will be a study session on March 12th with the update.

*

Vegetation and Tree Ordinances. Councilmember Carter expressed his appreciation to Staff, the Tree Board, Utility companies, and Councilmember Hickman for pouring themselves into the Vegetation and Tree ordinances over the last year and making them something the City of Norman can be proud of. He said one of the reasons he ran for City Council was to do something about the trees on Berry Road.

Councilmember Hickman said he is very excited about these two ordinances which started out in the Community Planning and Transportation Committee.

*

Welcome to University Students. Councilmember Clark welcomed the University of Oklahoma (OU) student that attended the meeting tonight. She said she appreciated them engaging in local government; it is the most important form of government.

Councilmember Scott welcomed the students and said she was also an OU Graduate student in Public Administration. She said she graduates in May and cannot wait to take a break.

*

International Women's Day. Councilmember Clark said she is very excited that about International Women's Day. She said this is the 100th Anniversary of the women's right to vote.

*

Miscellaneous Discussion, continued:

Thanks to Pioneer Library System. Councilmember Clark said she wants to send her appreciation to the Pioneer Library System for all of the wonderful events they held to celebrate Black History Month. She said next year she would like the City of Norman to have events to celebrate as well.

*

Thanks to Kappa Alpha Psi. Councilmember Clark thanked members of Kappa Alpha Psi for hosting the Ebony Awareness Bowl at City Hall. She said this fraternity also mentors middle school students at Alcott and Irving Middle Schools.

*

Vision for Norman. Councilmember Clark said the deadline to register the vote is March 9th for the upcoming election. She said this election is everyone's opportunity to stand up for our community and create and support a Vision for Norman. She said this election is incredibly important. She said a lot of the pieces of the Stormwater Bonds and Stormwater Utility will help with that. Norman is the largest city in Oklahoma without a Stormwater Utility. She said this is the time to invest in transportation infrastructure as well as stormwater infrastructure and water quality. She encouraged students to join us in sharing in the Vision.

Councilmember Holman said in the campus precinct cast less than 30 votes in the Municipal Election a few weeks ago. He said it is important for students to vote in the local elections and worth it to register to vote in Norman. Residents will be voting on April 2nd and three of the Transportation Bond projects will directly impact the campus area. He said Jenkins Avenue from Lindsey Street to Lloyd Noble Center will be widened to four lanes with bike lanes, center median, and continuous Americans with Disability Act (ADA) sidewalks; Constitution Street from Jenkins Avenue to Classen Boulevard will be widened to three lanes with bike lanes and continuous ADA Sidewalks; and Lindsey Street from Pickard Avenue to Jenkins Avenue will have bike lanes and continuous ADA compliant sidewalks. He said the flooding issue at Lindsey Street and Elm Avenue will be addressed with this project. He said the City is interested in working with OU to make some changes to the pedestrian crossings on Lindsey.

Councilmember Scott encouraged all of the students to get out and vote. She will be on campus with her megaphone registering people to vote and encouraging them to vote.

Regional Transportation Authority (RTA). Councilmember Holman said he, Mayor Miller, Councilmember Clark, and Councilmember Bierman attended the official kickoff of the RTA governing board on Wednesday, February 20th. The meeting was held in downtown Oklahoma City at the Santa Fe Station. He said the Mayors of Edmond, Moore, Del City, Midwest City and Oklahoma City were there as well as former Governor Brad Henry. He said this board will bring public transit to the Oklahoma City area of which Norman is included. This includes a metropolitan interconnected bus system and commuter rail system that will connect Norman to Edmond and Tinker Air Force Base with Downtown Oklahoma City being the central hub. Norman will have two stops, Highway 9 and Lindsey Street. He said the City of Norman member on the board is Marion Hutchison who is very knowledgeable about public transit.

Thanks to Ward Seven Voters. Councilmember Holman thanked the residents of Ward Seven for re-electing him to a fourth term on City Council. He said there was a record turnout in Ward Seven. He said he never thought he would be the longest seated City Councilmember. He is excited to keep working with Council.
