Item 20, being:

MISCELLANEOUS DISCUSSION

Abortion. Ms. Tammy Dodson, Ward 8, read scripture from the Bible and said City Council's duties are to adopt ordinances, discuss recycling and animals, pass bonds, approve infrastructure and she prays along with everything they do. She said no amount of intimidation, slander, or threats of harming their business will deter them from proclaiming what many are talking about but not verbalizing. She said she does not want abortion in our city. She said for far too long, women have believed the lie that they get to decide whether or not to kill, but that choice has already been made. She voiced concerns that while women are shouting out and crying for the right to kill, forsaking their own flesh and blood, that part of their soul dies along with that baby. She asked if the conscience can be ignored for the sake of what we call liberty.

Ms. Jennifer Robertson said there are 43,600 homeless children in Oklahoma; many living in Norman. She said there are children who do not have foster homes and these children are hungry every night. She said these are things our City government can do something about. She said the City government has no business or ability to control women's reproductive health. She understands there is no rule at this point about coming to Council for miscellaneous comments, whether it relates to city government or not but felt it showed a great deal of disrespect for the process. She said people are being threatened, largely because Mr. Dodson and his wife have shared all of this on social media and on various platforms which are, in theory, Christian. She said 46% of the citizens of Norman say that they are religious, of that 46%, 11% are non-Christian religions, Jewish, Muslim, Hindu, etc. She said there is no agreement in any of the Christian churches regarding when life begins. She said for someone to come before Council and shame probably half the women in Norman and say they do not have the right to decide what happens to their bodies, to inflame hatred and possible violence against the one doctor in Norman that continues to be here after many years so he can provide desperate women with a health solution is wrong. She said the one thing all religions have in common is that all of them say that judgment is left to God, not to anyone else. Many of these same people do not think any form of birth control should be used and that women's husbands and fathers should control all of their reproductive choices.

Mr. Shane Dodson, Ward 8, said he appreciates the Mayor reciting the rules about Miscellaneous Discussion. He said City business is moral, such as collecting taxes and deciding what to do with the tax money. He quoted Bible scripture and said this morality has a foundation and it is God's word. He said it is immoral to kill children and he hopes everyone agrees to that. It is wrong to take any group of people made in the image of God, male or female, black or white, rich or poor, young or old, and declare them as subhuman and therefore not deserving full protection under the law. He said let it stand as a testimony for those who have their backs turned that they are somehow turning their back on what he is saying. He said some people say the fetus is not human and yet fetuses contain every biological component necessary for human life. As followers of Christ, we believe that every life is worthy of full legal protection.

Ms. Vicki Lavistida, Chateau Drive, said she remembered being taught that women should not make waves or be unladylike. She said she is almost 50 years old and has grown weary of worrying about others' discomfort. She recounted actions at the last meeting and means no disrespect to anyone sitting before her. She said since two of the Councilmembers chose to call out other Councilmembers for their behavior, she feels compelled to do the same. She said women should be able to protest however they choose.

Miscellaneous Discussion, continued:

<u>Abortion, continued</u>. Mr. Brady Brewer, Ward 5, said he is a follower of Jesus Christ and he is here to be a voice of the voiceless. He said he finds it interesting that he is here because he cares about babies and it is interesting that it is considered hate speech. He quoted Bible scripture and urged Council to protect these children and stand for life.

Mr. Gary Barksdale, Ward 8, said his Councilmember had told him that signs would not be allowed in here and he thinks that City Councilmembers should be subject to the same rule. He expressed concern about what is going on behind the dais and how it affects the citizens of Norman. He said whenever any elected official behaves in a manner that results in any private citizen unjustly suffering as a result of their actions, it is the responsibility of free men and women to voice their concerns. He said a government official on this Council acted in such a way that incited her echo chamber to call for the destruction of a private citizen's business. He said another Councilmember made a public accusation against private citizens with whom she disagreed, of hate speech. He said City Councilmembers should be held to the same standard as citizens. He said, yes, there have been threats and hate speech, and they have been made against the Pro-Life people who have voiced their opinions. He said the First Amendment guarantees the rights of citizens to petition to the government for the redress of grievances without fear of reprisal.

Councilmember Bierman said she is always listening regardless of whether or not you can see her face. She said thousands of women die due to pregnancy related complications before, during, and after their children are born. She said Oklahoma has a terrible maternal mortality rate; so bad that the governor has convened a Mortality Rate Panel to address the issue. Oklahoma is ranked 34th for maternal mortality, 43rd for infant mortality, and 60% of the complications that kill these women are preventable. She said there are 568 children ready for adoption right now and 9,600 in state custody. She would like to know what everyone in this room is going to do to reduce those numbers.

Councilmember Scott said she turned her chair around when a constituent talked about abortion which is not a City issue. She said politicians do not dictate women's autonomy or reproductive justice. She said it is reasonable to disagree and she will not be turning her chair again. She said the discussion should focus on City issues and things that Council can control and not things that are going to divide us. She said it is shameful because people might not know what a woman has been through. She read some disturbing comments that she has received from people and said it has gone too far.

*

Council Residency. Ms. Lauren Lackey, 1130 Grover Lane, said she was here to discuss residency requirements for City Councilmembers. She said the home her Ward Four representative claims is his residence is available on Airbnb after being removed from the site a month before his mayoral campaign and had remained off the site up until at least a month ago. She said there are, as of 7:30 p.m., five days available in March, 25 in April, 20 in May. She asked City Council to acknowledge that her ward representative is in no way following in the spirit or intent of the law. She said she believes that none of City Council believes that he is living in that residence, so does this mean that if a Norman resident owns several properties and pays a utility bill at that residence that they can pick and choose where to claim to live. She asked that the Charter be amended to strengthen the definition of residency and be specific about the requirements and validation process as well as adding penalties for not complying.

*

Norman North/Norman High Girls State Basketball Playoffs. Councilmember Castleberry commended Norman High and Norman North Girls' Basketball teams for making it to the state playoffs and congratulated Norman High girls for winning the State Championship.

*

<u>Thanks to Sutton Wilderness Volunteers</u>. Councilmember Clark thanked the 65 volunteers that helped clean up Sutton Wilderness last Saturday, March 9th. She said almost 400 pounds of trash had been picked up. She said this cleanup was a partnership between Ward 6 and Ward 8 residents, the Stormwater Division, Parks and Recreation, Norman Police Department, the Homeless Outreach Division, City Council, and the Blue Thumb Volunteers.

*

Miscellaneous Discussion, continued:

Senate Bill 1001. Councilmember Clark said Senate Bill 1001 authored by Senator Leewright will pre-empt the City from creating an ordinance that will deal with single use bags. She said regardless how people feel about the ordinance, she hopes we can all stand together and value local control and recognize government overreach when we see it. She thinks this is a local issue because it deals with our environment and our drinking water. She is mounting a campaign to defeat the bill and stand with local control. She is reaching out to local officials from other cities because they are dealing with the same problem that Norman has, because plastic bags cannot be recycled. She said the Oversight Committee will be discussing the current proposal on Thursday, March 14th, at 4:00 p.m. in the City Council Conference Room.

Councilmember Holman said he spent some time at the State Capitol last Spring trying to get legislators not to pre-empt this issue. He said it is true the bags cannot be recycled and there is nowhere that takes these bags to recycle.

*

Children with Special Needs. Councilmember Clark said Norman is an inclusive community and has recently hired an Americans with Disabilities Act (ADA) Technician to help update the ADA Plan. She feels that children with Special Needs are being overlooked. She said Norman Public Schools does such a great job of providing services for children of all abilities and families will move here to get that kind of special assistance. She said she was told tonight that there is a single mom who likely has mental health issues with an 11 year old son who is non-verbal and has reached a point where he is physically strong and has some temper issues. He came to school with marks on his face indicating abuse and after reporting that there were issues, the Department of Human Services told her there was nowhere to take him. She said the state departments are ill-equipped to take care of our children. She said there are no daycare facilities for children with Special Needs. She said she would like to see Council work on this issue.

<u>Trip to Washington D.C.</u> Councilmember Holman said he and Mayor Miller went to Washington D.C. last week to meet with Norman's Federal Delegation. He said issues in Norman from infrastructure funding to weather research grants were discussed. He said the University of Oklahoma (OU) received the largest grant in the history of OU for weather related issues. He said the Interstate 35 and Indian Hills Road interchange was discussed with legislators. He said the highlight of the trip was the reception at Capitol Hill where Senator Langford gave them a private tour of the Senate floor. He said he and the Mayor also toured Washington D.C. City Hall. He thought it was interesting that the Washington D.C. Councilmembers are full-time employees and make over \$100,000 per year. He said it was a great trip.

<u>Vision for Norman</u>. Councilmember Scott said there is a Stormwater Utility and Transportation Bond Program, "Vision for Norman", which will be voted on April 2nd. She said this will fund infrastructure which is used by everyone. She encouraged people to support this measure.
