## **TEMPORARY CONSTRUCTION EASEMENT**

## Know all men by these presents:

That the STATE OF OKLAHOMA, acting by and through the OFFICE OF MANAGEMENT AND ENTERPRISE SERVICES, on behalf of the J.D. McCarty Center of Cleveland County, State of Oklahoma, for and in consideration of the sum of Ten Dollars (\$10.00) and other good and, valuable consideration, has this day sold to the City of Norman, a temporary easement over the following described land to wit:

A strip, piece or parcel of land lying in part of the NE¼, Section 28, Township 9 North, Range 2 West, I.M., Cleveland County, Oklahoma. Said parcel of land being described by metes and bounds as follows:

Commencing at the Southeast corner of said NE¼, thence N 00°14'41" W along the West line of said NE¼ a distance of 704.75 feet, thence S 89°45'19" W a distance of 33.00 feet to a point on the present West right-of-way line of 24th Avenue NE, said point being the point of beginning, thence continuing S 89°45'19" W a distance of 5.04 feet, thence N 00°14'41" W a distance of 28.00 feet, thence S 89°45'19" W a distance of 11.96 feet, thence N 00°14'41" W a distance of 76.00 feet, thence N 89°45'19" E a distance of 11.96 feet, thence N 00°14'41" W a distance of 30.00 feet, thence N 89°45'19" E a distance of 5.04 feet to a point on said present West right-of-way line, thence S 00°14'41" E along said present West right-of-way line a distance of 134.00 feet to the point of beginning.
