PART I - GENERAL

SCOPE

Work includes materials, delivery and installation. Furnish and install all furnishings as specified herein.

SUBMITTALS

Product data: Manufacturer's descriptive literature shall be submitted, indicating materials, finishes, construction and installation instructions, and verifying that product meets requirements as specified.

Manufacturer's recommendations for maintenance and cleaning shall be included.

Samples: Submit samples of each exposed finish, fabric and leather (which will be used for actual production) to Interior Designer for verification and approval prior to ordering.

QUALITY ASSURANCE

Supplier: The manufacturer, subsidiary or licensed agent shall be approved to supply the products specified, and to honor any claims against the product presented in accordance with the warranty.

Installer: The installer or agent shall be qualified to install the specified products by prior experience, demonstrated performance and acceptance of any requirement of the manufacturer or any subsidiary or licensed agent. The installer shall be responsible for an acceptable installation.

DELIVERY, STORAGE AND HANDLING Product shall be delivered to the project site in manufacturer's original packaging.

Product shall be handled and stored to prevent damage to materials and finishes.

PART 2 – PRODUCTS

Substitution requests: Burden of proof that proposed substitutions shall be equal in quality and function to the specified product is on the Bidder.

Acceptable manufacturers: Stylex or approved equal.

VERVE CHAIR

Frame: The chair shall be constructed with polished cast aluminum frame with built-in lumber support. Aluminum 4-bladed base shall be swivel and fixed height.

Finish: All aluminum chair parts shall be washed, powder coated and baked and cured in the same cycle to provide color.

Seat: The chair seat shall be an upholstered injection molded plastic shell attached to frame carriage with four 1/4-20 rust resist steel screws and washers tighten to four brass inserts to prevent rusting. The shell shall be made from recyclable polypropylene that contains 30% glass filler.

Foam: The foam shall be I" of CFC-free, high-density polyurethane foam adhered with water based adhesive foam to inside and outside of injection-molded polypropylene shell. The fabric shall be adhered to the foam and shall be included 2 zippers for maintaining proper shape during upholstery process. The shell shall be upholstered prior to being attached to frame.

Casters: Hard white plastic caster with 55mm diameter wheel shall be attached to base. Casters shall include a 9.6mm steel stem and gray caps on the sides.

PART 3 – EXECUTION

Subcontractor shall be responsible for inspection on project site and approval of installation conditions for this work.

Installation shall comply with manufacturer's specification, standards and procedures.

Clean finished installation of dirt and finger marks. Leave work area clean and free of debris.
