### PART I - GENERAL

#### SCOPE

Work includes materials, delivery and installation. Furnish and install all furnishings as specified herein.

### **SUBMITTALS**

Product data: Manufacturer's descriptive literature shall be submitted, indicating materials, finishes, construction and installation instructions, and verifying that product meets requirements as specified.

Manufacturer's recommendations for maintenance and cleaning shall be included.

Samples: Submit samples of each exposed finish, fabric and leather (which will be used for actual production) to Interior Designer for verification and approval prior to ordering.

### **QUALITY ASSURANCE**

Supplier: The manufacturer, subsidiary or licensed agent shall be approved to supply the products specified, and to honor any claims against the product presented in accordance with the warranty.

Installer: The installer or agent shall be qualified to install the specified products by prior experience, demonstrated performance and acceptance of any requirement of the manufacturer or any subsidiary or licensed agent. The installer shall be responsible for an acceptable installation.

### DELIVERY, STORAGE AND HANDLING

Product shall be delivered to the project site in manufacturer's original packaging.

Product shall be handled and stored to prevent damage to materials and finishes.

## PART 2 – PRODUCTS

Substitution requests: Burden of proof that proposed substitutions shall be equal in quality and function to the specified product is on the Bidder.

Acceptable manufacturers: Allermuir or approved equal.

### MOLLIE CHAIR

Construction: The chair frame and shell shall be constructed from clear finished walnut veneer with black power coated aluminum leg frame. The conical legs shall be constructed from solid walnut wood with clear finish. The glides provided shall be plastic with felt. The upholstered seat shall be upholstered prior to being attached to the body. The upholstered seat and back are not detachable without tools.

Leg Frame Finishing: The raw frames shall be coated with a primer,

baked and cured. Paint shall then be applied, backed and cured, with a final top coat being applied to seal the finish.

# **AXYL CHAIR**

Construction: The chair base frame shall be constructed with power coated cast aluminum. The seat and back shall be plastic with color to match the base color. The glides provided shall be plastic.

Stacking: Axyl arm chairs stack up to 4 high on the floor and stacking buffers are provided per chair.

Leg Finishing: The raw frames shall be coated with a primer,

baked and cured. Paint shall then be applied, backed and cured, with a final top coat being applied to seal the finish.

### PART 3 – EXECUTION

Subcontractor shall be responsible for inspection on project site and approval of installation conditions for this work.

Installation shall comply with manufacturer's specification, standards and procedures.

Clean finished installation of dirt and finger marks. Leave work area clean and free of debris.




