

GROUP L: LYON

PART 1 – GENERAL

SCOPE

Work includes materials, delivery and installation.
Furnish and install all furnishings as specified herein.

SUBMITTALS

Product data: Manufacturer's descriptive literature shall be submitted, indicating materials, finishes, construction and installation instructions, and verifying that product meets requirements as specified.

Manufacturer's recommendations for maintenance and cleaning shall be included.

Samples: Submit samples of each exposed finish, fabric and leather (which will be used for actual production) to Interior Designer for verification and approval prior to ordering.

QUALITY ASSURANCE

Supplier: The manufacturer, subsidiary or licensed agent shall be approved to supply the products specified, and to honor any claims against the product presented in accordance with the warranty.

Installer: The installer or agent shall be qualified to install the specified products by prior experience, demonstrated performance and acceptance of any requirement of the manufacturer or any subsidiary or licensed agent. The installer shall be responsible for an acceptable installation.

DELIVERY, STORAGE AND HANDLING

Product shall be delivered to the project site in manufacturer's original packaging.

Product shall be handled and stored to prevent damage to materials and finishes.

PART 2 – PRODUCTS

Substitution requests: Burden of proof that proposed substitutions shall be equal in quality and function to the specified product is on the Bidder.

Acceptable manufacturers: Lyon or approved equal.

ALL-WELDED STORAGE CABINET

Construction: The cabinet with doors shall be constructed with 14 gauge steel. The heavy-duty steel doors shall also include three 5/16" diameter steel pin hinges welded to each door. The doors feature a secure, 3-point locking system. The rugged cast iron handle also includes a 3/8" thick. A welded 4" h forklift base shall be provided. Four heavy-duty steel shelves shall be provided. The adjustable shelves shall have capacity of 1,450 lbs per shelf.

ECONOMICAL STORAGE CABINET

Construction: The cabinet shall be constructed with durable heavy-gauge steel. The door shall be provided quiet door feature to reduce noise. A polished chrome handle with a three-point locking system in door shall be provided. Adjustable shelves shall hold up to 180 lbs each.

BULK STORAGE RACK

Construction: The frame shall be constructed with 14-gauge steel and 2 welded uprights. The metal storage rack shall come with 4 Levels and 5/8" thick particle boards.

PART 3 – EXECUTION

Subcontractor shall be responsible for inspection on project site and approval of installation conditions for this work.

Installation shall comply with manufacturer's specification, standards and procedures.

Clean finished installation of dirt and finger marks. Leave work area clean and free of debris.
