


## **Next Steps**

- Adopt Transition Plan June 26, 2018
- Establish a Council-appointed permanent ADA Citizen Advisory Committee (FYE 2019)
- Hire a full-time ADA Technician (FYE 2019, January 2019)
- Continue with next phase of project
- Begin implementation of improvements based on findings from evaluated facilities (FYE 2019)
  - Improvements to programs, services, and activities
  - Integrate with existing capital improvement projects
  - Create new projects

# **Next Phase**

- Remaining facility evaluations
  - Facilities recommended to be completed over the next three (3) years:
    - 20 Buildings
    - 20 Parks
- Staff training
  - Quarterly training modules with various City Departments
- Transition Plan updates
  - ADA Coordinator and ADA Staff Liaison Committee to work on implementing improvements
  - Establish internal procedures to monitor and track progress





#### The Project Manager's Role

- Represents the city. Not a member of the committee.
- Do the work as agreed
- Report on project programs
- Recruit professional input as required
- Be responsible for recording Committee decisions



# Member Attributes

- Have a known vested interest in success
- Be motivated for the project to succeed
- Represent a specific constituency
- Be willing to agree to the committee's goal and objectives
  - Be able to perform the roles and responsibilities of membership
  - Understand the strategic implications and outcomes of the initiatives being pursued



# Member Qualifications

• An individual with a disability.

Mobility, Hearing, Vision, Cognitive and/or neuro-atypical

A professional who serves the population of people with disabilities.

Schools, Veterans, and other disability service professionals

• The parent or primary caregiver of an individual with a disability.



# The Committee Charge

The City of Norman ADA Citizen Advisory Committee is being established to serve as a resource to civic leaders on issues affecting people with disabilities and the ways by which the City of Norman can be more accessible and usable for everyone.
