## **COUNCIL COMMENTS:**

Mayor Clark extended her thanks and gratitude to Robert Castleberry and Lynne Miller. She said Robert has been the longest serving Councilmember and finance expert. She said she learned a lot from him, he has guided her through some time issues, and he will be greatly missed. She asked him to stay involved because the City of Norman needs him. She said Lynne Miller's services to Norman has spanned over several decades and she can say confidently that she has made Norman a better place. She said Lynne has steered the Council through some difficult issues and her leadership has set Council up for success going forward. She said it is up to this Council to see it all through. She said she is personally grateful for Lynne's support and guidance that she has shown over the last several months and although Lynne has assured her that she will be there for her, she promises to let her enjoy retirement as much as possible.

Mayor Clark said this is an exciting time for her and her family and she has received so much support from family, friends, and residents. She thanked everyone, especially those who are here from out of state. She said she would not be here without her husband's support; he put up with her insane schedule; her incessant debate with local politics; and all the yard signs in the garage.

She said he is everything to her. With that said, her role as mom will always be the most important role that she ever had. She said, as the Mayor of this great city, she is committed to prioritizing inclusivity, collaborating with our partners; and leading with respect. She asked the same of her colleagues. She is confident that Council can work as a team, be open and honest with each other and when we disagree, they will do it respectfully. She said Norman needs us to be a team and we are stronger together. There is a sense of hope and optimism in the city that has been missing for some time, but to all of those here tonight and watching from home, she challenges them to stay engaged, continue to follow the issues; attend meetings; engage your family, co-workers and neighbors about what is going in our city. She said local government is the most important level of government because the decisions we make here in City Hall impact everyone far quicker than decisions made in Oklahoma City and Washington D.C. and we want you with us. She said if her last three years on Council has taught her anything, the next three years will be filled with challenges and opportunities, successes and failures, and continued traditions along with change. She said she is ready for it.
