On or about August 27, 2019, damage was sustained to a Traffic Signal Cabinet and Battery Back-up Cabinet located near the OnCue construction site at State Highway 9 and Classen Boulevard. Chris Serrano, Public Works Construction Manager, investigated the incident and found that elevation changes were made to the site by a contractor working for OnCue/Tri-City Construction. These changes resulted in the pooling of rainwater directly around and into the City owned Cabinets, compromising the electronics of both.

Traffic Signals, Inc., has accepted responsibility and submitted full payment in the amount of \$12,860.37 to cover damage costs. Please find this payment attached and advise if further information is needed.
