### STAFF REPORT

# ITEM: Consideration of <u>NORMAN RURAL CERTIFICATE OF SURVEY NO. COS-2021-8, INDIAN HILLS RIDGE ESTATES.</u>

**LOCATION:** Generally located one-half mile north of Indian Hills Road and on the west side of 144<sup>th</sup> Avenue N.E.

#### **INFORMATION:**

- 1. Owners. Oklahoma Wildlife Properties.
- 2. <u>Developer</u>. Oklahoma Wildlife Properties.
- 3. Engineer/Surveyor. Pollard and Whited Surveying.

#### **HISTORY:**

- 1. October 21, 1961. City Council adopted Ordinance No. 1317 annexing this property into the Norman Corporate City limits without zoning.
- 2. October 30, 1961. Planning Commission recommended to City Council that this property be placed in A-2, Rural Agricultural District.
- 3. <u>December 12, 1961</u>. City Council adopted Ordinance No. 1322 placing this property in A-2, Rural Agricultural District.

#### **IMPROVEMENT PROGRAM:**

- 1. Fire Protection. Fire protection will be provided by the Norman Fire Department.
- 2. <u>Sanitary Sewer</u>. Individual septic systems will be installed in accordance with City and Oklahoma Department of Environmental Quality standards.
- 3. <u>Water</u>. Individual water wells will be installed in accordance with City and Oklahoma Department of Environmental Quality standards.
- 4. <u>Easements</u>. A private roadway, drainage and utility easement is included in the documents for Indian Hills Ridge Estates. Covenants will address the maintenance responsibility for the owners.

There is a 100' width Oklahoma City water line easement located on Tract 5.

- 5. <u>Private Road</u>. There is a proposed private road to serve the property. City Standards require a private road with a width of twenty-feet.
- 6. Acreage. Tract 1 consist of 10.002 acres, Tract 2 consist of 10.004, Tract 3 consist of 10.001, Tract 4 consist of 10.001, Tract 5 consist of 10.005, Tract 6 consist of 10.001, Tract 7 consist of 10.001 and Tract 8 consist of 10.001 acres. The property consist of a total of 80.016 acres.
- **SUPPLEMENTAL MATERIAL**: Copies of a location map, Norman Rural Certificate of Survey No. COS-2021-8 are included in the Agenda Book.
- **STAFF COMMENTS AND RECOMMENDATION**: All of the tracts will be served by a private road. Access to all of the tracts will be from the private road. Staff recommends approval of Certificate of Survey No. COS-2021-8 for Indian Hills Ridge Estates.
- **ACTION NEEDED**: Recommend approval or disapproval of Certificate of Survey No. COS-2021-8 for Indian Hills Ridge Estates to City Council.
