Please read all the instructions below to understand the next steps. <u>Please note that starting</u> this year NACCHO is requiring the submission of deliverables from units to receive funding. Funding will be distributed in two separate payments of 50% each upon receipt of deliverables outlined below in the award payment process.

1. Contract processing steps:

- a. NACCHO will send an electronic copy of your unit contract in approximately 2-4 weeks to the person listed in the application with signing authority and a cc to the MRC unit leader.
- b. Review the contract and notify NACCHO of any errors for the listed agency, address, or signature authority.
- c. Review Paragraph 3 of the contract which lists the organization's obligations for receipt of award funds, including deliverables and registered status in SAM.gov.
- d. Return the following documents electronically to mrc@naccho.org by March 22, 2021:
 - i. Signed contract and signed certification of non-debarment or suspension. Please send both in one scanned document.
 - ii. Unit action plan and invoice for first payment of the award (see below for instructions). Please send as a separate document from the contract and non-debarment form.

2. Award payment process:

a. Awards will be paid in two separate payments equal to 50% of the award upon receipt of invoice and required deliverables listed below:

i. Deliverable I MRC Operational Readiness Action Plan

- 1. Due by March 22, 2021
- 2. Use the action plan template provided by NACCHO.
- 3. Use the information you provided in your application to complete the action plan.
- 4. Send Invoice and select "Deliverable I" along with unit action plan to <u>mrc@naccho.org</u> by due date.
- ii. Deliverable II MRC Operational Readiness Interim Progress Evaluation
 - 1. Due by July 31, 2021
 - 2. NACCHO will send out an interim progress evaluation through the application awards website in early June 2021 to the individual who submitted the application.
 - 3. Notify NACCHO if the contact person or email needs to be updated to ensure receipt of the interim survey application.
 - 4. Send Invoice and select "Deliverable II" upon completion of the interim progress survey to mrc@naccho.org by the due date.
- 3. Budget and use of funds reminders:

- a. Use the MRC Operational Readiness Award funds as outlined in your budget to support MRC response capabilities. Funds should not be used to support non-MRC agency activities or purchases.
- b. Follow all applicable guidelines, laws, and executive orders. Please see Federal Guidance <u>45 CFR Part 75</u> and <u>2 CFR Chapter I, Chapter II, Part 200</u> (Uniform Administrative Requirements, Cost Principals, and Audit Requirements for Federal Awards) for guidance on using federal funding.
- c. Any branding of durable equipment purchases must include the MRC brand to acknowledge the intent of the funding. Equipment purchases are not transferable to partner agencies or organizations.
- d. Gift cards used as incentives, stipends, or as a form of reimbursement are not allowed.
- e. Promotional recruitment "giveaways" are not allowed.
- f. Notify NACCHO for requests for budget modifications that exceed 10% of the overall budget.
